## MAHARASHTRA ACT No. XXI OF 2017.

(First published, after having received the assent of the Governor in the "Maharashtra Government Gazette", on the 18th January 2017.)

An Act further to amend the Maharashtra Land Revenue Code, 1966.

WHEREAS it is expedient further to amend the Maharashtra Land Mah. Revenue Code, 1966, for the purposes hereinafter appearing; it is hereby 1966.

1. This Act may be called the Maharashtra Land Revenue Code (Fifth Short title. Amendment) Act, 2016.

2. In section 35 of the Maharashtra Land Revenue Code, 1966 Amendment Mah. XLI of (hereinafter referred to as "the said Code"),-1966.

of section 35 of Mah. XLI of

(a) in sub-section (2), for the words "at such price not exceeding  $\frac{1966}{1966}$ . twenty-four times the assessment thereof" the words " at such price not exceeding twenty-four times the assessment thereof or such amount as may be prescribed, whichever is higher," shall be substituted;

(b) in sub-section (4), for the words "equal to three times the assessment" the words "equal to three times the assessment or such amount as may be prescribed, whichever is higher," shall be substituted.

**3.** In section 44 of the said Code, in sub-section (5), for the words of section 44 "such fine as the Collector may, subject to rules made in this behalf direct 1966, not exceeding five hundred rupees" the words "such fine not exceeding five hundred rupees or such amount as may be prescribed, whichever is higher, as may be directed by the Collector" shall be substituted.

4. In section 44A of the said Code,—

(a) in sub-section (3), in clause (a), in sub-clause (i), for the words "such penalty not exceeding rupees ten thousand; as the Collector may subject to the rules, if any, made in this behalf direct" the words "such penalty not exceeding rupees ten thousand or such amount as may be prescribed, whichever is higher, as the Collector may direct" shall be substituted;

(b) in sub-section (4), in clause (a), for the portion beginning with the words "further penalty" and ending with the words "one hundred rupees", the following shall substituted, namely :----

"further penalty not exceeding five thousand rupees or such amount as may be prescribed, whichever is higher, for such contravention, and a daily penalty not exceeding one hundred rupees or such amount as may be prescribed, whichever is higher,".

5. In section 45 of the said Code, in sub-section (2), for the portion Amendment of section 45 beginning with the words " person a penalty" and ending with the words of Mah. XLI of 1966.

> "person a penalty not exceeding three hundred rupees or such amount as may be prescribed, whichever is higher, for such contravention, and a further penalty not exceeding thirty rupees or such amount as may be prescribed, whichever is higher,".

6. In section 47A of the said Code,—

(a) in sub-section (2), for the words "five times" the words "five times or such amount as may be prescribed, whichever is higher, of " shall be substituted ;

(b) in sub-section (3), for the words "five times" the words "five times or such amount as may be prescribed, whichever is higher, of " shall be substituted.

7. In section 49 of the said Code,—

(a) in sub-section (2), in clause (iv), in sub-clause (b), for the words and figures "at a rate of 25 paise " the words " at the rate of twentyfive paise or such amount as may be prescribed, whichever is higher," shall be substituted ;

(b) in sub-section (10), for the words "not exceeding one hundred rupees" the words "not exceeding one hundred rupees or such amount as may be prescribed, whichever is higher," shall be substituted.

(ii) for the words "fifty rupees" the words "fifty rupees or as may be prescribed, whichever is higher," shall be substituted.

9. In section 51 of the said Code, for the words "five times", at both Amendment the places where they occur, the words " five times or such times as may of section 51 be prescribed, whichever is higher, of " shall be substituted. 1966.

10. In section 53 of the said Code, in sub-section (3), for the words Amendment " two times the assessment or rent for land" the words " two times the of section 53 assessment or rent for land or such amount as may be prescribed, whichever 1966 is higher," shall be substituted.

11. In section 70 of the said Code, in the proviso, for the words " one Amendment rupee only "the words " one rupee or such amount as may be prescribed, whichever is higher" shall be substituted.

12. In section 72 of the said Code, in sub-section (3), for the words Amendment "three times the assessment" the words " three times the assessment or such times the assessment as may be prescribed, whichever is higher" 1966. shall be substituted.

13. In section 110 of the said Code, in sub-section (2),—

(a) for the words "ten paise "the words "ten paise or such amount of Mah. XLI of as may be prescribed, whichever is higher," shall be substituted ;

(b) for the words "five paise " the words " five paise or such amount as may be prescribed, whichever is higher," shall be substituted.

14. In section 129 of the said Code and the proviso thereto, for the Amendment words " one rupee " at both the places where they occur, the words " one of section 129 rupee or such amount as may be prescribed, whichever is higher, " shall be 1966. substituted.

15. In section 174 of the said Code, for the words "twenty-five per Amendment of section 174 cent. of the amount not so paid " the words " twenty-five per cent. of the of Mah. XLI of amount not so paid or such amount as may be prescribed, whichever is 1966. higher" shall be substituted.

16. In section 229 of the said Code, in clause (c), for the words of section 229 "fifty rupees" the words "fifty rupees or such amount as may be prescribed, 1966. whichever is higher " shall be substituted.

17. In section 266 of the said Code, in the proviso,-

(a) for the words " one rupee per annum" the words " one rupee per annum or such amount as may be prescribed, whichever is higher" shall be substituted ;

(b) for the words "thirty times the assessment" the words "thirty times the assessment or such amount as may be prescribed, whichever is higher" shall be substituted.

Amendment 18. In section 267 of the said Code, in sub-section (2), after the word of section 267 and letter "Schedule F" the words " or of such higher amount as may be of Mah. XLI of 1966. prescribed, whichever is higher " shall be added.
