#### MAHARASHTRA ACT NO. XXXVIII OF 2016.

(First published, after having received the assent of the Governor in the "Maharashtra Government Gazette", on the 21st December 2016).

An Act further to amend the Maharashtra Municipal Councils, Nagar Panchayats and Industrial Townships Act, 1965.

Mah. WHEREAS it is expedient further to amend the Maharashtra Municipal XL of

1965. Councils, *Nagar Panchayats* and Industrial Townships Act, 1965, for the purposes hereinafter appearing; It is hereby enacted in the Sixty-seventh

1. This Act may be called the Maharashtra Municipal Councils, Nagar Short title. Panchayats and Industrial Townships (Amendment) Act, 2016.

shall be added, namely :---

"Provided that, in case of the Municipal Council where the President is directly elected under section 51A-1A, the President so elected shall nominate the Councilors under clause (b).".

Amendment of section 51A-1A of Mah. XL of 1965. 3. In section 51A-1A of the Principal Act, in sub-section (9),—

(*i*) for the words "The Collector" the words, "The President" shall be substituted;

(ii) the following shall be added at the end :--

"Notwithstanding anything contained in sub-section (3) of section 51A, the President elected under section 51A-1A, shall have a second or casting vote.".
