MAHARASHTRA ACT No. XXIX OF 2017.

(First published, after having received the assent of the Governor in the "Maharashtra Government Gazette", on the 15th April 2017).

An Act to amend the Maharashtra State Commission for Backward Classes Act, 2005.

WHEREAS both Houses of the State Legislature were not in session ;

AND WHEREAS the Governor of Maharashtra was satisfied that Mah. XXXIV of action to amend the Maharashtra State Commission for Backward Classes 2006. Act, 2005, for the purposes hereinafter appearing ; and, therefore, Mah. promulgated the Maharashtra State Commission for Backward Classes Ord. IV of 2017. (Amendment) Ordinance, 2017 on the 9th January 2017 ;

AND WHEREAS it is expedient to replace the said Ordinance by an Act of the State Legislature ; it is hereby enacted in the Sixty-eighth Year of the Republic of India as follows :—

1. (1) This Act may be called the Maharashtra State Commission for Short title and Backward Classes (Amendment) Act, 2017. commence-(2) It shall be deemed to have come into force on the 9th January 2017. ment.

In section 3 of the Maharashtra State Commission for Backward of section 3 of Classes Act, 2005 (hereinafter referred to as "the principal Act"), in sub-section (2), in clause (c), for the words " six members, one member each " the words " eight members, at least one member each " shall be substituted.

(2) Notwithstanding such repeal, anything done or any action taken (including any notification or order issued) under the principal Act, as amended by the said Ordinance, shall be deemed to have been done, taken or issued, as the case may be, under the corresponding provisions of the principal Act, as amended by this Act.
