## CHAPTER I

### PRELIMINARY

Short title. **1.** This Act may be called the Orphanages and Other Charitable Homes (Supervision and Control) the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) and the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) (Maharashtra Amendment) Act, 2009.

## CHAPTER II

### AMENDMENTS TO THE ORPHANAGES AND OTHER CHARITABLE HOMES (SUPERVISION AND CONTROL) ACT, 1960.

Amendment of section 5 of 10 of 1960. **2.** In section 5 of the Orphanages and Other Charitable Homes (Supervision and Control) Act, 1960, in its application to the State of Maharashtra (hereinafter referred to as “the Orphanages and Charitable Homes Act”), in sub-section (2), for clause (a), the following clause shall be substituted, namely :—

“(a) two members of the State Legislative Assembly nominated by the Speaker of the State Legislative Assembly from amongst the members of the State Legislative Assembly and one member of the State Legislative Council nominated by the Chairman of the State Legislative Council from amongst the members of the State Legislative Council ;”.

Amendment of section 6 of 10 of 1960. **3.** In section 6 of the Orphanages and Charitable Homes Act, in sub-section (1), in the proviso, for the words, brackets and letters “elected under clause (a) or clause (b)” the words, brackets and letters “nominated under clause (a) or elected under clause (b)” shall be sustituted.

## CHAPTER III

### AMENDMENT TO THE PERSONS WIHT DISABILITIES (EQUAL OPPORTUNITIES, PROTECTION OF RIGHTS AND FULL PARTICIPATION) ACT, 1995.

Amendment of section 13 of 1 of 1996. **4.** In section 13 of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995, in its application to the State of Maharashtra, in sub-section (2), for clause (g), the following clause shall be substituted, namely :—

“(g) three members of the State Legislature, of whom two shall be nominated by the Speaker of the State Legislative Assembly from amongst the members of the State Legislative Assembly and one by the Chairman of the State Legislative Council from amongst the members of the State Legislative Council ;”.

CHAPTER IV

AMENDMENT TO THE BUILDING AND OTHER CONSTRUCTION WORKERS  
(REGULATION OF EMPLOYMENT AND CONDITIONS OF SERVICE) ACT, 1996.

5. In section 4 of the Building and Other Construction Workers (Regulation of Employment and Conditions of Service) Act, 1996, in its application to the State of Maharashtra, in sub-section (2), for clause (b), the following clause shall be substituted, namely :—
