#### An Act further to supplement certain provisions of the Evacuce Interest (Separation) Act, 1951, in its application to the State of Maharashtra.

LXIV WHEREAS, it is expedient further to supplement certain provisions of of the Evacuee Interest (Separation) Act, 1951, in its application to the State of 1951. Maharashtra, for the purpose hereinafter appearing;

It is hereby enacted in the Eleventh Year of the Republic of India as follows :---

1. (1) This Act may be called the Maharashtra Evacuee Interest Short title, (Separation) Supplementary Act, 1960.

(2) It extends to the whole of the State of Maharashtra.

(3) It shall be deemed to have come into force on the 15th day of October 1960.
