#### MAHARASHTRA ACT No. XXVII OF 2025.

An Act further to amend the Maharashtra Krishna Valley Development Corporation Act, 1996.

Short title and commencement.

1. (1) This Act may be called the Maharashtra Krishna Valley Development Corporation (Amendment) Act, 2025.

(2) It shall come into force on such date as the State Government may, by notification in the *Official Gazette*, appoint.

Amendment of section 2 of Mah. XV of 1996

dment **2.** In section 2 of the Maharashtra Krishna Valley Development Mah. tion 2 Corporation Act, 1996, in clause (c), the brackets and words "(except Koyna XV of 1996. Hydro-Electric Power Project)" shall be deleted.

Declaration.

3. It is hereby declared that, from the date of commencement of the Maharashtra Krishna Valley Development Corporation (Amendment) Act, Mah. 2025, the Koyna Hydro-Electric Power Project is assigned, handed over and transferred to the Maharashtra Krishna Valley Development Corporation; and the aforesaid commencement date shall be the appointed date in respect of the said Project, for the purposes specified in section 15 of the Maharashtra Mah. Krishna Valley Development Corporation Act, 1996.
