Note.- On perusal of documents of student who have applied through the option of Master of Laws (LL.M) Course, it appears that none of them is pursuing Master of Laws (LL.M) Course. Thus no one is eligible for selection through the Master of Laws (LL.M) Course. Therefore, Ms. Vaishnavi Ashok Bedekar who has applied in 5 Years Law Course and Mr. Ajaz Ahmed Khan who has applied in 3 Years Law Course are selected against the vacant seats of LL.M based on merit list.

- 2. Twelve students (6 boys and 6 girls) are selected on the basis of the following criteria:-
 - (1) In order to give an opportunity to students of different Law Colleges/ Universities in the State of Maharashtra 12 students from 12 different Colleges / Universities.
 - (2) One student from one Law College is selected.
 - (3) Selection is based on MH-CET/ CLAT Marks.
 - (4) Students having knowledge of Marathi language with ability to read and write have been given preference.
 - (5) From 5 Years Law Course 7 students are selected.
 - (6) From 3 Years Law Course -5 students are selected.
