

Note.- Shri. Arth Shah who has applied for the 'Legislation Internship Program' from the LL.M Course was selected for the Programme. However, he has communicated via Whatsapp, that he is unable to attend the said Programme. Therefore, Ms. Akanksha Rajendra Balavantrao who has applied in 5 Years Law Course is selected against the vacant seats of LL.M based on merit list.

Twelve students (5 boys and 7 girls) are selected on the basis of the following criteria:-

- (1) In order to give an opportunity to students of different Law Colleges/ Universities in the State of Maharashtra 12 students from 12 different Colleges / Universities.
- (2) One student from one Law College is selected.
- (3) Selection is based on MH-CET/ CLAT Marks.
- (4) Age limit 28 years.
- (5) Students having knowledge of Marathi language with ability to read and write have been given preference.
- (6) From 5 Years Law Course - 7 students are selected.
- (7) From 3 Years Law Course -4 students are selected.
- (8) From LL.M Law Course – 1 students are selected.
