With reference to the above mentioned Slum Rehabilitation Scheme and on the basis of documents submitted by the applicant, this office is pleased to issue **Revise Letter of Intent (LOI)** subject to the following conditions.

1. That all conditions mentioned in Letter of Intent issued under No. SRA/ENG/001/SEC-2/PVT/LOI, dtd.16/11/2022 & dtd.16/05/2023 shall be complied with.

2. This Revise Letter of Intent is issued on the basis of plot area certified by the Architect and as per Certificate of 3(C) dated 21/04/2016 and other and a second comments.

This Revise LOI is valid for the period of 6 (six) months from the date of issue. However, if IOA/CC are obtained for any one bldg. of the project then this revised LOI will remain valid till validity of IOA/CC.

The built up area for sale and rehabilitation shall be as per the following scheme parameters. In the event of change in area of plot, Nos. of eligible that etc. the parameters shall be got revised from time to time.
