- 2. This Revise Letter of Intent is issued on the basis of plot area certified by the Architect and the Annexure-II issued by Competent Authority and other relevant documents.
- 3. This revised LOI is valid for the period of 6 (six) months from the date of issue. However, if IOA/CC are obtained for any one bldg. of the project then this revised LOI will remain valid till validity of IOA/CC.

- 6. The Developer shall comply with the conditions mentioned in Govt. Notification dated 28/06/2017 and dtd.18/01/2019 for MOEF as applicable before granting further CC to Composite Building.
- 7. The NOC from CFO of TMC for Composite Building Rehab Wing and Sale Building Rehab Wing shall be insisted before Plinth CC of Composite Building Rehab Wing and Sale Wing respectively.
 - All the conditions mentioned in the previous LOI & IOA shall be complied with at appropriate stages.
- 9. That the Developer shall submitted PRC in the name of Govt. of Maharashtra before grating further CC to Sale Wing of Composite Building.
