- 1. If the bidder is a Micro or Small Enterprise as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Experience Criteria" as defined above subject to meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 2. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
- 3. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. The bidder seeking exemption from Experience Criteria, shall upload the supporting documents to prove his eligibility for exemption.
- 4. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
- 5. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 6. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in

support of having provided services during each of the Financial year.

- 7. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

 8. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price.
- 9. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 10. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Buyer Added Bid Specific ATC

SCOPE OF WORK FOR MESS FRUITS AND VEGETABLES TENDER

The purpose of this tender is to engage a reliable and experienced supplier for the supply and delivery of fr esh vegetables and fruits on a daily basis, as per the requirements of the buyer organization. The successf ul bidder shall be responsible for the following:

1. Supply of Items

- o The supplier shall provide a wide range of fresh vegetables and fruits.
- The list of items may vary based on seasonal availability and the buyer's requirements.
- Quantities and types of items will be specified by the buyer on daily basis.

2. Quality Requirements

- All produce must be fresh, clean, wholesome, and free from decay, damage, or pest infestation.
- Items must be sorted and graded, conforming to standard market classifications (e.g., Grade A).
- Fruits and vegetables should not be chemically ripened or artificially colored.
- The buyer reserves the right to inspect the goods at the time of delivery and reject any item that do es not meet the required standards.

3. Packaging

- Items must be properly packed in clean, food-grade containers or baskets to prevent spoilage and c ontamination during transit.
- Perishable items like leafy vegetables and fruits should be packed in a way that maintains freshness and avoids bruising or damage.

4. Delivery Schedule

- Deliveries must be made on daily basis as per the demand schedule communicated by the buyer.
- Delivery time must strictly adhere to the agreed schedule, typically between 6:00 AM to 10:00 AM.
- The supplier must ensure doorstep delivery to the designated site i.e. National Institute for the Emp owerment of Persons with Visual Disabilities (Divyangjan), NIEPVD, 116, Rajpur Road, Dehradun - 2 48001 (Uttarakhand).

5. Transportation

• The supplier shall arrange for their own transport facilities to ensure timely delivery without depend ence on third-party logistics.

6. Order Execution and Reporting

- All orders will be placed on daily basis, and the supplier must acknowledge receipt and provide confirmation of dispatch.
- A delivery challan/invoice must accompany each consignment.

7. Substitution and Replacement

- If any item is out of stock or unavailable, the supplier must notify the buyer at least 24 hours in adv ance and suggest a suitable replacement (subject to buyer approval).
- Rejected items must be replaced within 04 hours at no additional cost.

•

TERMS AND CONDITIONS

- 1. If the quality and quantity of fruits and vegetables is not found good. The institute will deduct the amount from the bill received from the firm.
- 2. Supply of fruit and vegetables will be checked by the Catering Officer of the institute or his represent ative daily.
- 3. The fruit and vegetables will be supplied daily by 10:00 AM.
- 4. Rates of fruit and vegetables will be mentioned in **Per Kg./Per Dozen** etc.
- 5. Payments of bills received from the suppliers/distributors will be done in the following month.
- 6. If there is fluctuations/rises in the price of fruits and vegetables in market, there will be no effects in the approved tender rates. As these rates are approved for the **Two Years.**
- 7. The supplier should have an authorized dealer registered in fruits and vegetables market. Copy of le tter should be enclosed in the tender documents.
- 8. Quantity of fruit and vegetables may vary depending on the Menu and strength of students/Trainees for the month.

Payment Terms and Conditions

The following terms shall govern the payment process for the supply of vegetables and fruits under this tender:

1. Mode of Payment

- All payments shall be made **electronically.**
- No cash or manual payment shall be entertained under any circumstances.

2. Payment Schedule

- Payment shall be made monthly basis **only after successful delivery**, inspection, and acce ptance of the goods by the authorized representative of the buyer.
- A **bill** shall be provided to initiate payment processing.
- Standard payment processing time is **within 10 to 30 days** from the date of acceptance an d invoice submission.

3. No Advance Payment

• No advance payment shall be made.

4. Deductions

- Payments may be subject to deductions for:
 - Supply of substandard or rejected items.
 - Any applicable taxes, duties, or levies as per Government rules.

5. Taxes and Statutory Deductions

- TDS (Tax Deducted at Source), if applicable, shall be deducted as per Government norms.
- The supplier must mention their **GSTIN** and ensure that **GST invoices** are issued in complia nce with applicable tax laws.
- The buyer shall not be liable for any taxes or duties other than those mentioned in the PO.

6. Bank Details

- The supplier must ensure their **bank details are correctly mentioned** for seamless proces sing of payments.
- Any delay due to incorrect bank details shall be the responsibility of the supplier.

7. Disputes on Payment

- In case of any discrepancy or dispute regarding the payment, the matter shall be addressed amicably and resolved within 15 working days.
- Unresolved disputes may be escalated to the competent authority or resolved as per the Dispute Resolution clause in the tender.

Penalties

To ensure timely and quality supply, the following penalties shall be applicable in case of default by the supplier:

1. Delay in Delivery

- If the supplier fails to deliver the goods within the stipulated time mentioned in the Purchase Order (PO), a penalty of **5% of the total order value per day of delay** shall be imposed.
- The maximum cumulative penalty for delay shall not exceed 10% of the total order value.
- Beyond this, the buyer reserves the right to **terminate the contract** and/or procure the ite ms from an alternate source at the risk and cost of the defaulting supplier.

2. Rejection Due to Poor Quality

- If supplied items are found to be of **substandard quality**, **damaged**, or **not as per specifi cations**, they will be **rejected** outright.
- The supplier must replace the rejected goods within 04 hours of intimation.
- Failure to replace within the stipulated time will result in a penalty of ₹500 per item/consig nment.

3. Non-Delivery or Short Supply

• In case of **non-delivery or short delivery** without prior approval or intimation, a penalty of **5% of the undelivered value** shall be levied per instance.

• Repeated incidents (more than 3 in a contract period) may lead to **blacklisting** of the suppli er on GeM and **termination of the contract**.

4. Incorrect or False Invoicing

Any instance of inflated billing, false quantities, or unauthorized items in invoices shall result in immediate suspension of payment and a penalty of ₹1,000 per instance, in addition to any legal actions as per applicable laws.

6. Dispute Resolution Related to Penalties

- If the supplier disputes any penalty imposed, they may submit a written representation within **7 working days** of such imposition.
- The decision of the competent authority shall be final and binding.
- The Competent Authority has deserved all rights to cancel the Tender at any phas e.

अस्वीकरण/Disclaimer

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the

same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
