#### 2. Forms of EMD and PBG

Bidder has to upload scanned copy/ proof of the FDR along with bid and has to ensure delivery of hardcopy to the Buyer within 5 days of Bid End date/ Bid Opening date

## 3. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

#### 5. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1-All Water purifiers (RO) in NIEPVD CAMPUS are engaged by Eureka Forbes Company. Therefore, the bid s pecific OEM authorisation certificate issued by the Eureka Forbes Company is mandatory to be uploaded on GeM Portal.
- 2-The Head Office/Branch office of the service provider should be in Consignee Location Dehradun Uttarak hand. A certificate to that effect is mandatory to be uploaded on the portal.
- 3-It is mandatory for the service provider to upload a copy of the certificate for the respective category in MSME on the portal.
- 4-Engineer Name, Contact no., office contact no. is mandatory for local service provider Certificate.
- 5- Original/Genuine spare parts related to water purifier/purifier cum water cooler/water cooler i.e. PCB, UV Lamp, LED indicator, switches, solenoid valves are covered in AMC.
- 6-Service engineer has to visit the site for inspection within 2 working days of filing the complaint.
- 7- During service visits, water cooler/water purifier/water cooler cum purifier will be thoroughly checked, c leaned, serviced and adjusted.
- 8-Replacement and servicing of compressor should be considered in AMC plan. Warranty/guarantee shall be provided by the firm on replaced compressor.
- 9-At least one service engineer should be provided in NIEPVD during office hours is mandatory.
- 10-Payment should be made on quarterly basis after satisfactory report of work .
- 11-The AMC may be cancelled at any time if the service is not found satisfactory.
- 12-The working of water purifiers may be checked physically by the bidder before bidding.
- 13-The payment for the AMC charges will be made on quarterly basis on submission of the bill duly suppor ted by user certificate to the effect that all machines have been serviced and are working in good conditio n.
- 14-No advance payment will be made any circumstances. TDS will be deducted as per applicable laws. The maintenance charges, quoted by the agency are on yearly basis and inclusive of all taxes and levies as per various laws/regulations/ Act. (s) applicable.
- 15-The successful bidder has to execute an agreement with APL in a non-judicial stamp paper of denomina tion not less than Rs. 100.00 within 10 days after issue of LOI / Work Order.
- 16- All consumable like Sediment filter, carbon filter, membrane filters, would be covered twice under AM C period. It should be Genuine Aquaguard Make Only.
- 17- All electrical and electronic parts will be replaced as when required N numbers of time.
- 18- All refrigeration parts will be covered under AMC period.
