PAN India Legal Awareness and Outreach Program

The 45 days long PAN India Awareness and Outreach Campaign as a part of Azadi Ka Amrit Mahotsav, is being celebrated across the country from 2nd October 2021 to 14 November 2021, under aegis of NALSA New Delhi. On the concluding day of this campaign, a program is organized by NALSA at New Delhi on 14th November i.e. Children's Day.

State Legal Services Authority in association with High Court of Madhya Pradesh on November 14, 2021 in the premises of High Court Jabalpur.

Justice Nandita Dubey, Hon'ble Shri Justice Vishal Mishra, Hon'ble Shri Justice Purushaindra Kumar Kaurav, Shri Rajendra Kumar Vani, Registrar General, M.P. High Court and other dignitaries.



As we are aware that 45-days long campaign regarding PAN INDIA Awareness & Outreach Programme was inaugurated on 2nd Oct. by the National Legal Services Authority, by this programme every citizen has to be informed and aware about the activities of the legal services and its schemes, while ensuring the reach of the Legal Services Institution thrice to every village of the state, in the course of which, in coordination with the State Legal Services Authority, the District Legal Services Authority has ensured access thrice time to reach every village of the state during the said period and public awareness campaign has been conducted through camps / Melas etc.

The Legal Services Week has been organized from November 8 to November 14, 2021. In this week, other activities such as door-to-door programmes, legal literacy programmes, legal aid clinics and publicity vehicles and other means, along with additional activities such as organizing mega camps, due to corona epidemic, have been organized across the State. During the said programme, it has been ensured the benefits of the schemes of the state / central government are provided to the children who have lost their parents due to Covid, legal literacy camp for women empowerment under joint collaboration of the National Commission for Women, painting / essay / slogan writing / film for children Organizing making competitions, moot court competition in law colleges and Prabhat Pheri on the last day of the campaign and online live broadcast of the campaign closing program organized by NALSA, etc., have been organized while strictly following Covid-19 protocol and the guidelines of the government.

During the above program, about 9,000 outreach teams including Panel



Lawyers, PLV, Asha workers, Anganwadi workers, employment assistants, law students and persons associated with legal services etc. have been formed and each village of the state has been ensured to access in thrice.

Celebrating Constitution Day (26.11.2021)

On 26th November 2021, under the aegis of National Legal Services Authority, New Delhi “Constitution Day” was celebrated by District Legal Services Authorities/High Court Legal Services Committees and Tehsil Legal Services Committees across the State under guidance of Hon'ble Chief Justice and Patron-in-Chief, Madhya Pradesh State Legal Services Authority & Hon'ble Administrative Judge, M.P. 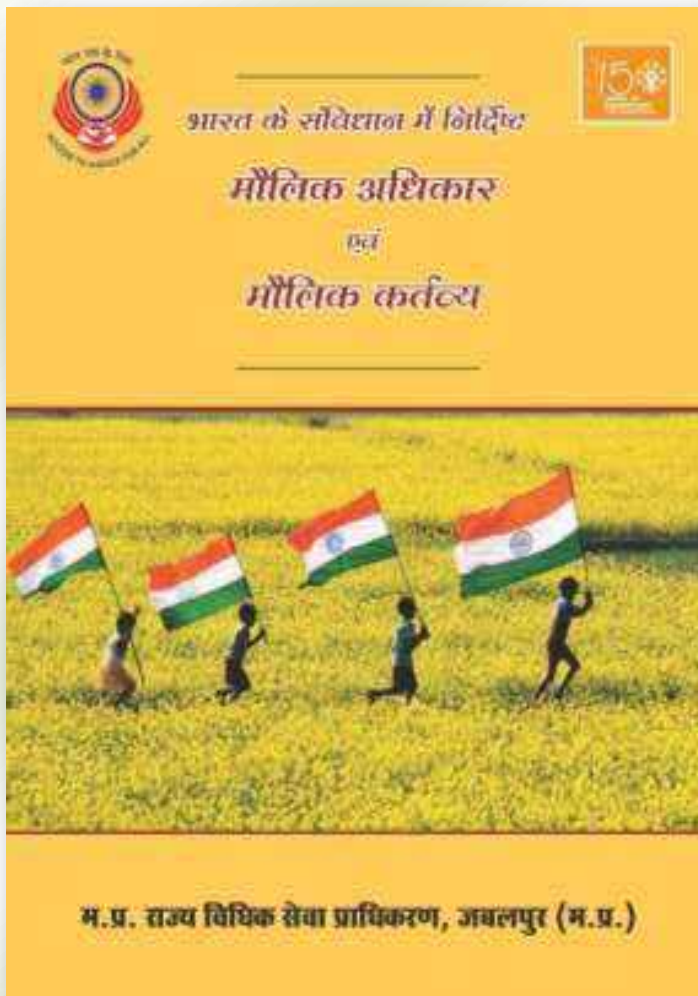

MEDIATION



In the mediation awareness programmes, general public is made about resorting to settle their dispute through mediation and its benefits over litigation. Parties are explained that mediation is a voluntary process and they retain all the rights and powers, any party can withdraw from the process of mediation at any phase without stating a reason. Mediation encourages the parties to participate in dispute resolution actively and directly whereby they explain the facts of their dispute, lay down options or ways to resolve the dispute and make a final decision by coming to a settlement.

Emphasis was also given that it is a completely private method of dispute resolution. Only the disputing parties and the mediator are involved, making the affairs of the parties personal and private. The mediator is an impartial and independent third party, who helps the parties in finding their own solution. All statements made during the process of mediation in India cannot be disclosed in civil proceedings or any other place without the prior consent of all parties in writing.

Public was also made aware that Mediation is completely confidential as any information furnished by any party and a document prepared or submitted is inadmissible and sealed. Any admission made during mediation cannot be used in any other court case and any information provided to the mediator cannot be disclosed to the other party unless the other party specifically permits the mediator to do so. The mediator cannot be called as a witness to testify in any court case and cannot disclose any information related to the proceedings.

Bal Seva Pension provided to children orphaned during Covid-19

In awareness campaign as a part of “Azadi ka Amrit Mahotsava” under the directions of DLSA, a door to door campaign survey was also done by Paralegal Volunteers and Anganwadi workers in coordination with the administration. They identified orphans 1. Ayushi, 2. Alok 3. Kaynath, who lost their families because of Covid-19. After completing all the procedures, assistance to the said children was given and their pension started under “*Bal Seva Scheme*”, after which these children have started getting financial assistance of Rs. 5000/- a month from the government. With the coordinated efforts of District Legal Services Authority & Women and Child Development Department, now the government will bear all the education related expenses of the above children.

Anukampa appointment given to daughter-in-law of deceased Anganwadi worker in Covid-19

In the awareness campaign cum survey under door to door campaign in Azadi ka Amrit Mahotsav, Para legal Volunteers alongwith Anganwadi workers in Covid-19 informed Secretary, District Legal Services Authority, about the pending case of Anukampa appointment after the death of Anganwadi worker Morbai of village Khari. By the efforts of the District Legal Services Authority, Girija Bai, the daughter-in-law of the deceased Anganwadi worker, was given Anukampa appointment and appointment letter was also given to her by the Principal District Judge / Chairman of DLSA.

Chanda Verma, who has been mentally tortured since 10 months, came to the Legal Aid Clinic, Janpad Panchayat, Badhwah and told PLV about her problem and lodged her complaint. The Paralegal Volunteer after listening to all her problems talked to Raman Upadhyay, Sarpanch and Secretary of Village Kadwalia, told Secretary Raman Upadhyay all the problems of Chanda and asked for his help. Raman Upadhyay helped her to prepare all the documents of Chanda Verma like husband's death certificate, Aadhar card from Gram Panchayat and also helped her to apply in Bank and get another pass book. The Paralegal Volunteer, after contacting the concerned department in Janpad Panchayat, Barwah, helped Chanda Verma for sanctioning an amount of two lakhs and got the rights of applicant and her children. The amount received from the above grant was deposited in the bank by the beneficiary in the name of his children.



DLSA RAISEN

After second wave of Corona, a co-ordinated effort was made by DLSA, Raisen alongwith Women and child development department to trace children who lost their parents during lockdown of Covid-19. Thereafter 26 children were identified who had lost both parents during second wave of Corona and they got registered under "Chief Minister Covid-19 Bal Kalyan Yojana" by Women and child development department and after approval, now they are getting Rs. 5000/- monthly pension under the scheme.

Thereafter during PAN INDIA AWARENESS AND OUTREACH PROGRAMME, as directed, again an effort was made to grant benefit to such children under the 'PM CARES for Children' scheme and two children (name not being disclosed as they are also child in need of care and protection and JJ Act 2015 prohibits the publication of names of such children) they were registered in PM care scheme and now there cases have been approved and their bank accounts have been opened on 12-11-2021 and the amount as mentioned in the scheme will be transferred shortly.
