Legal services institutions are working from Taluka court level to Hon'ble Supreme Court level. Legal Aid clinics are established across the nation in villages, in Jails, in District Court premises, in Juvenile Justice boards, in Child Welfare Committees, in law colleges etc. Legal literacy clubs also established in schools. Para legal volunteer and panel Lawyers providing their services to reach out each and every aggrieved person to resolve their grievances. Various Legal services schemes run by NALSA and MPSLSA. Just like legal services institutions, government bodies are also providing their services through schools, health centers, aanganwadis across the nation to provide Health & Education facilities and benefits of Government Welfare schemes.

The purpose of the said program is to make the collaboration and coordination between Legal services Institutions and government bodies more effective and more cohesive along with focus more on collaborative work between legal services institutions and government bodies through these clinics, literacy clubs, centers and other activities, so every needy person can avail the benefits of legal services schemes as well as government welfare

## Statewide Online Awareness Program Organized for Prisoners under Pan India Awareness & Outreach Campaign

All the District Legal Services Authorities including Taluka Legal Services Committees across the State have been directed to organize legal literacy camps/ Fair/exhibition/door to door campaign and other legal service activities following the Covid-19 protocol and government guidelines in the period between October 2 to November 14, 2021. Outreach Teams at each district and tehsil level have been constituted including paralegal volunteers, panel advocates, Anganwadi workers, social workers, law students and faculty members as its members by the concerned District Legal Services Authorities. जिला विधिक सेवा प्राधिकरण ग्वालियर द्वारा नालसा की गरीबी उन्मूलन विधिक सेवा योजना के क्रियान्वयन हेतु गठित टीम की पैनल अधिवक्ता कु. शिल्पा डोंगरे के पास एक गरीब छात्रा कु. पायल तोमर, निवासी किला गेट हजीरा ग्वालियर उपस्थित हुई। उक्त छात्रा के पिता एक सिक्स्योरिटी गार्ड के रूप में नौकरी करते थे। छात्रा इण्टरमीडिएट की परीक्षा में 90 प्रतिशत से अधिक अंको से उत्तीर्ण हुई थी एवं वह आई.आई.टी की तैयारी कर इंजीनियर बनना चाहती थी परन्तु आर्थिक रूप से कमजोर होने से बेहद परेशान एवं मायूस थी।

छात्रा के भविष्य को ध्यान में रखते हुए पैनल अधिवक्ता कु. शिल्पा डोंगरे एवं सामाजिक संस्था के द्वारा छात्रा की मदद हेतु लक्ष्मीबाई कालोनी स्थित मोलुक्यूलर क्लासेस के संस्थापक से सम्पर्क कर छात्रा को आई.आई.टी. की तैयारी हेतु निःशुल्क कोचिंग प्रदान किये जाने सहायता मांगी गयी, जिसे संबंधित संस्था के प्राचार्य द्वारा स्वीकार कर उक्त छात्रा को अपने संस्थान में निःशुल्क कोचिंग प्रदान किये जाने हेतु सहमति प्रदान की।

जिला विधिक सेवा प्राधिकरण जबलपुर कार्यालय में पशुपतिनाथ नेपाली मंदिर समिति से निराश्रित दिव्यांग महिला उर्मिला थापा, उम्र 72 वर्ष का आवेदन प्राप्त हुआ। वृद्ध महिला किराये के मकान में निवास कर रही है एवं उसके परिवार में उसकी देखभाल के लिए कोई भी सगा संबंधी नहीं है। वृद्ध महिला का एक पैर गैंग्रीन के कारणवश कट गया है और दूसरा पैर पूर्व से ही खराब था।

उक्त महिला के संबंध में जैसे ही सहायता आवेदन प्राप्त हुआ तो त्वरित कार्यवाही करते हुए उसके रहवास हेतु वृद्धाश्रम में व्यवस्था करायी गयी परन्तु महिला जब वृद्धाश्रम में जाने के लिए तैयार नहीं हुयी तो उसके लिए विकलांगता प्रमाण पत्र बनवाया गया ताकि महिला को विकलांगता पेंशन का लाभ मिल सके जिससे वो अपना जीवनयापन कर सके।

Simulated hand holding exercise was conducted to demonstrate how police officers manning the help desk could work in co-ordination with panel Advocates or para legal volunteers nominated from the LSI. It is expected that this training will make a quantum change in assisting women who face sexual harassment at home or work place or children who are subjected to any kind of emotional or physical trauma.

## WORKSHOP ON WITNESS PROTECTION SCHEME

### DLSA BHOPAL

DLSA Bhopal organized a workshop for Sensitisation of Police Officers on the witness protection scheme on 23.10.2021. The Witness Protection Scheme has been given effect through the judgment of the Hon'ble Supreme Court in Mahindra Chawla & ors. Vs. Union of India & ors. WP Criminal 156, 2016. To sensitise the police officers on the need for witness protection and to facilitate effective co-ordination with the Legal Services Authority to the extent of protection not only for the victim but also to the witness at the pre trial, during trial and after the trial stage up to the award of victim compensation and rehabilitation. The Hindi translation of the Scheme has been prepared and uploaded on the web site so that police officers may be able to give full effect to the directions of Hon'ble the Supreme Court.
