

The objectives include promoting public awareness of conciliatory dispute resolution and empowering citizens to participate in the justice system.

The Madhya Pradesh State Legal Services Authority (MPSLSA) organizes Lok Adalats in regular intervals to enhance access to justice, aligning with its goal of ensuring equal legal opportunities for all citizens, particularly the marginalized.

Unlike litigation, mediation empowers the parties to control the outcome by prioritizing their interests rather than rigid positions. The mediator guides discussions, identifies barriers to agreement, and fosters an environment conducive to collaboration and understanding. This process is confidential and encourages open dialogue, often preserving relationships post-dispute.

The Madhya Pradesh State Legal Services Authority (MPSLSA) aims to promote mediation as an effective alternative dispute resolution mechanism, enhancing access to justice and reducing court congestion.



This landmark ruling emphasized that transgender individuals are entitled to equality, dignity, and the right to self-identify, thus prohibiting discrimination based on gender identity. The Court directed the government to implement measures for social and economic upliftment, including reservations in education and employment.
