ABOUT LEGAL AID CLINIC

The NLIU - Legal Aid Clinic ("LAC"), which is driven by the ethos of Article 39A of the Indian Constitution, has been established under the aegis of the National Legal Service Authority. It is a student-run initiative, which aims to provide free legal aid to the marginalized sections of the society. Our aim is to provide pro bono legal representation and advice to the weak and downtrodden. Additionally, we also organize various legal literacy workshops and training programmess to spread legal awareness to further the cause of legal literacy.

Our major projects include Project Saarthi (Pro Bono legal advice, representation, mediation and mental health counselling services initiative), Aapke Adhikaar (Legal literacy initiative for common people), Project Bail (Initiative for underprivileged and undertrial prisoners), Project Pukaar (Detailed information on social-legal issues which are often not discussed) and Project Neev (Initiative to promote establishment and development of Legal Aid Clinics with exchange of information and resources). Our ancillary activities include Lok Adalat visits, participation and organisation of various capacity building programmes, organisation of legal literacy development initiatives for student community, legal awareness and data collection drives, Nukkad Nataks, etc.

Our achievements in the past year include handling over 60 pro-bono cases under Project Saarthi, organizing Jan Sunwaii at Kekadiya village, Speed Mentoring sessions at both rural and urban schools, Nukkad Nataks and several legal awareness drives throughout villages in and around Bhopal along with the 2nd NLIU-LAC Workshop and Training Programme that witnessed the participation of more than 90 students and faculty members. Through these endeavors, we have empowered countless individuals with knowledge about their rights and also assisted other institutes with setting up and running a legal aid clinics.

None of these accomplishments would have been possible without the unwavering support of our esteemed student members. I would like to take this opportunity to thank my entire team of Legal Aid Clinic, which under the leadership of the Ms. Payal Dubey (Convener 2022-23) and Ms. Gaargi Singh (Co Convener 2022-23), has worked hard to achieve its objectives. I also sincerely hope and wish that the Legal Aid Clinic's journey continues and that it further serves the legal needs of society's underprivileged groups with a stronger sense of devotion and compassion."

1. PARTICIPATION IN CAPACITY BUILDING SESSIONS

1.1 VISION INDIA@2047 FOR JUDICIAL SYSTEM




The event was organised by The Department of Justice, Government of India where 16 law schools were invited to share their ideas on the theme 'Justice for All: Developing A speedy, affordable & Technology-enabled Citizen-Centric Doorstep Justice Delivery System.'

NLIU members Rashi Upadhyay, Surbhi Jain, Ishita Warghat, and Pushpendra Dixit participated in the consultation, sharing their ideas on evolution of new methods to clear pendency and backlogs of cases with the use of technology, empowerment of village panchayats to settle land disputes and enhancement of court's time and cost efficiency

1.2 CAPACITY BUILDING PROGRAM

NLIU-LAC participated in the 'Capacity Building for Pro Bono Associates', jointly organised by the Pro Bono Club of Parul Institute of Law, GNLU, Gandhinagar and RGNUL, Punjab, under the aegis of Pro Bono Club Scheme by the Department of Justice. The members of NLIU-LAC prepared a report which contains a brief summary of the enlightening sessions that were held. These sessions focused on the importance of mediation, proper methods to carry out legal aid practices, and the rights of victims, women, children, consumers and innovative topics such as Public Interest Lawyering.



2. PROF. V.S. MALLAR LEGAL AID COMPETITION

2.1 SURVEYS UNDER COMMUNITY HALT ACTIVITY AND AWARENESS DRIVES



The NLIU Legal Aid Clinic conducted a legal awareness drive in Bhanpur village this year. The Clinic's members visited around 40 to 50 homes and explained the legal rights and remedies available to individuals. They also conducted surveys collecting data on the legal issues faced by school-going children, daily wage workers, and contract workers as well as documents they may require to avail government benefits.


An awareness drive was also conducted in the Kekadiya village of Bhopal. It covered 100 houses and informed individuals of the village about their legal rights and remedies. The main purpose of the drive was to collect data on the number of children attending school in the village with a special focus on female literacy. The prevailing problems related to mid-day meals, availability of uniform, books etc. were noted. Apart from this, members of the family were asked if they had a bank account under the Pradhan Mantri Jan Dhan Yojna; if they knew the biometric system provided in their Aadhar Card; and the usage of their EWS Card and Caste Related Certificates. Lastly, especially during the hard-hit Covid-19 period, the individuals were asked and informed about the financial support they could receive from the Government.

2.2 NUKKAD NATAKS

It is believed that knowledge is best gained through visual depictions and thus, NLIU-LAC organized street plays on various social issues to make people aware of their rights. NLIU-LAC organized a street play on the theme 'elderly rights' to spread awareness on the rights of the elderly in front of the residents of the Kekadiya-Bhanpur Village. It conveyed the various rights, remedies, and protections available to the elderly in India, including the provision of ration, gas connection, pension, and schemes introduced by the government.

Further, NLIU-LAC in collaboration with Aahwan, the Drama Society of NLIU presented a street play on the issue of Domestic Violence in Bhanpur Village, Mendori. The play depicted scenarios of physical and mental abuse in a regular household and live-in relationships. The public was informed of their civil and legal rights enshrined in the Domestic Violence Act, the Indian Penal Code (section 498A), and other legislations. The act was concluded with the distribution of pamphlets that included relevant details, such as contact number and services provided, in case they face any issues.

2.3 SPEED MENTORING SESSIONS

NLIU-LAC also organised a Speed-Mentoring session in the Mendori school on the topic 'Child Abuse and Child Sexual Harassment'. The session, aimed at imparting knowledge and awareness on the topics of 'Good-touch & Bad-touch' and 'Bullying' to the students. Children were also educated on the mental effects of abuse. The session concluded by providing different solutions to deal with such mishaps.

A second speed mentoring session was held in the government school in Kekadiya village where students were taught about child's rights under the 'right to education'. They were encouraged to continue their studies, as well as to motivate children around them who do not attend school or study. Another speed mentoring session at Carmel Convent School, Bhopal was conducted on the topic of domestic violence The session saw huge participation from the students' side. They interacted enthusiastically and were inquisitive enough to understand the intricacies of such a sensitive issue.



2.4 JAN SUNWAII

On 10th October 2022, Jan Sunwaii was conducted at the Kekediya on their rights regarding contract labourers and daily wages. It included a discussion of villagers with Mr. Prem Dohre, an activist and member of the Abhedya NGO, Dr. Debashri Sarkar, a woman's rights expert, Ms. Neha Sharma, the faculty coordinator for the Pro Bono Club Scheme of the Department of Justice at NLIU, and Dr. Uday Pratap Singh, the faculty-in-charge at NLIU-LAC. Along with other socially engaged senior members of the village, the panel also included Mr. Dalchand Banjara (Panchayat Sarpanch), Mr. Vinod Rajauria (Secretary and District Council Member), Mr. Ram Singh (Member, Abhedya NGO), and Ms. Kalavati Devi (District Council Member). The Clinic was able to conduct Jan Sunwaii smoothly with the help and support of Ms. Jasemin Ali (Assistant Labour Commissioner). The Clinic members had an eye-opening experience and the audience offered positive feedback.



3. PRO BONO CLUB SCHEME ('PBCS') BY THE DEPARTMENT OF JUSTICE


3.1 INFORMATION, EDUCATION and COMMUNICATION DEVELOPED

3.2 INTERACTIVE SESSION WITH Mr. BHAVIL PANDEY

Mr. Bhavil Pandey, an alumni of NLIU and a practicing advocate under the auspices of the Jabalpur Bench of the Madhya Pradesh High Court, who is also affiliated with Nyaya Bandhu (Pro Bono Legal Services), shared his experiences and insights on effectively running a legal aid clinic and handling pro bono cases. It was a valuable learning opportunity for all the attendees.



3.3 NLIU-LAC NEWSLETTER AND MONTHLY PROGRESS REPORTS

Prepared a newsletter of the activities undertaken by the Clinic in the first quarter of the Academic Year. It was shared with the Department of Justice, Ministry of Law and Justice, Government of India ('DOJ'), the members of faculty and students of NLIU, as a requirement under the PBCS.

Additionally, under the supervision of PBCS Faculty Co-ordinator, we prepared Monthly Progress Reports (MPRs) for the first semester of the AY 2022-23, as per the mandate of the Scheme, which was submitted to the DOJ.




3.4. FIELD VISITS

Field visit was held at Bhanpur village, prior to the legal awareness drive to check the viability of the location. Additionally, the Core members of NLIU-LAC visited the District Legal Services Authority, Bhopal and met Mr. S.P. Bundela, Secretary, DLSA Bhopal to seek assistance and guidance in managing mediation cases under Project Saarthi and conducting mediation related activities under Pro-Bono Club Scheme, respectively.



4. NLIU-LAC OFFICE SETUP

Hoardings were put up at the entrance of the NLIU Campus and at the NLIU-LAC Office as per the Resolution taken in the Internal Quality Assessment Cell (IQAC) Meeting of the University. Additionally, efforts were made to upgrade the interior of the office and make it suitable according to the requirements of the Clinic.



5. TRAINING SESSION ON BASICS OF MEDIATION

15 members of the NLIU Legal Aid Clinic, under the Department of Justice's Nyaya Bandhu Pro Bono Scheme and Mediation vertical of Saarthi, were pleased to visit the District Legal Services Authority, Bhopal for a short session on the basics of mediation. Mr. SPS Bundela, Secretary of the District Legal Services Authority, explained the process of mediation in great detail and it was an excellent learning opportunity for the members of LAC.



6. PARTICIPATION IN NALSA CAMPAIGN AND JAIL VISIT

Under Project Bail, NLIU-LAC co-ordinated the participation of 29 students from NLIU in the 13-day NALSA campaign themed

- i) "Empowerment of Citizens through Legal Awareness and Outreach" &
- ii) "Haq humara bhi to hai@75"

aimed at providing legal assistance in prisons and childcare institutions. In furtherance of the same, students visited the New Central Jail, Bhopal and actively interacted with prison inmates and collected requisite information.



8. PROJECT SAARTHI

Owing to the increased number of domestic violence issues and mental health matters as reported by the National Commission for Women, NLIU- LAC rebranded its initiative of proving free legal service as Project Saarthi in the year 2020. It was improved by introduction of two additional verticals- Mediation and Mental Health Counselling. We dedicated a helpline number aimed at providing free assistance to people coming up with mental health issues, and seeking legal advice or representation in general. The first vertical- Legal Assistance, is dedicated to the management of general civil and criminal matters with a special focus on domestic violence cases; second, the Mediation vertical aims to provide mediation and other ADR services by certified mediators; and lastly, the Mental Health Counselling vertical aims to provide counselling by professional psychologists.



Our empanelled advocates, psychologists, and certified mediators assist these three wings. The project aims at making effective legal aid accessible to all. We have successfully handled around 80 cases from all three verticals in the past years. [Kindly refer to Annexure 1 below for the number of Saarthi cases handled in the AY 2022-23]

9. 73RD CONSTITUTION DAY CELEBRATION

NLIU-LAC in collaboration with E-Nyayaganga, Bhopal, under the aegis of the Department of Justice, and the NLIU Student Bar Association was pleased to organise a lecture on 'Constitution Vision of Liberal Democracy' in celebration of the 73rd Constitution Day on 26th November, 2022. Prof. (Dr.) Vinod Dixit conducted an enlightening session and kept the students engaged and interested. It was a fruitful experience for the students of NLIU.



10. 3RD NLIU-LAC PIL DRAFTING COMPETITION

To commemorate the 73rd Constitution Day, NLIU-Legal Aid Clinic in collaboration with CLAP Legal Services Institution, Magna Peritus, a premier law firm in Bhopal, and Jan Sampark, Public Relations Department, MP, organised the 3rd NLIU-LAC PIL Drafting Competition 2022. The competition was aimed at providing an opportunity to the students to understand the legal and practical aspects of PILs. Students were awarded with cash prize upto Rs. 22,000 and certificates.



11. REPUBLIC DAY CELEBRATIONS

11.1. QUIZ AND TURNCOAT DEBATE COMPETITIONS ON CONSTITUTIONAL LAW

The Indian Constitution fosters individuals' dreams and embodies a living document as it allows for the fullest expression of each person's freedoms and wants while also enforcing the necessity for societal advancement.

In order to raise awareness about the Constitution and its unique aspects, NLIU-LAC in collaboration with Magna Peritus, a premier law firm situated in Bhopal, Jan Sampark, Public Relations Department of Govt of MP and Jus Cultura organised Quiz and Turncoat Competitions on the occasion of 74th Republic Day. Winners were awarded books, certificate of merit, and cash prize upto Rs. 16,000.

The quizmaster, Siddharth Sisodia, ran the competitive inter-college event in an engaging manner. The goal of the Turncoat Competition was to promote critical thinking and understanding of Indian politics and constitutional law. It featured two difficult rounds that were scored according to a number of standards by faculty members from NLIU. All in all, the competitions enlarged the engagement of the students with the contemporary challenges in the Constitutional law and political scene.



11.2. INTERACTIVE SESSION ON 'COMMUNALISM, MISINFORMATION AND SOCIAL MEDIA' UNDER LAC'S PROJECT PUKAAR

As part of the Republic Day celebrations and to mark the release of the fourth Project Pukaar Report, the NLIU-LAC in collaboration with NLIU Cell for Law and Technology hosted an interactive session on 'Communalism, Misinformation, and Social Media'. The discussion was presided over by Mr. Hemendra Sharma, State Head (Madhya Pradesh And Chhattisgarh Range), India Today, who contributed his invaluable time and expertise on the subject with attendees. Our alumnus Adv. Shantanoo Saxena also participated in the discussion and shared his insights. In addition, the findings of the Project Pukaar Report on 'Communalism, Misinformation and Social Media' were summarised and presented to the gathering by our student-member Mr. Akshay Ashok.



12. AWARENESS AND DATA COLLECTION DRIVES 2022-2023

To achieve the objectives of the Clinic, we organise Data Collection and Awareness Drives on a regular basis so that students can engage with the common people, make them aware about their rights and inform them about the existence of the Clinic and the kind of assistance it can provide to them in their legal matters. This helps us in gathering cases for Project Saarthi as well.

12.1 DATA COLLECTION DRIVE IN MENDORI

Since its inception, the residents of nearby Mendori village have acted as equal partners in the implementation of the activities of NLIU-LAC. To celebrate this partnership and strengthen the trust of the residents of Mendori



village, LAC revisited the area to conduct an interactive drive. Drive's aim was to reinforce the importance of access to the legal institutions for individuals, irrespective of their social standing. Nearly 30 members visited the area, interacted with the families, ensuring that no family or individual is left behind in our pursuit for 'access to justice for all.'

12.2 AWARENESS AND DATA COLLECTION DRIVE IN JAATKHEDI

On a sunny day in the village of Jaatkhedi, the Legal Aid Clinic (LAC) team arrived with a mission to educate and empower the community about their legal rights related to the Street Vendors Act, 2014. With the help of 22 paralegal volunteers, the LAC team conducted a legal awareness drive in the village.

The volunteers visited the area, interacted with the families and received more than 30 grievances from the villagers ranging from issues related to Aadhar Card, Pan card, Ration card, Caste certificate etc.



12.3 DATA COLLECTION DRIVE IN BARRAI



NLIU-LAC successfully conducted another drive, in the village of Barrai with a team of 30 students. The village had more than 500 people living. Volunteers walked the area, interacted with the families and received more than 50 grievances from the villagers ranging from issues related to property disputes, domestic violence, pension issues, Aadhar Card, Pan card, Ration card, Caste certificate etc.

The cases received from the drives above have been given proper advice and information as to how hey can approach the appropriate authorities regarding their respective cases. The LAC members taking care of these cases have been in constant touch with the clients if they face any issue in the process.

13. 2ND NLIU-LAC WORKSHOP AND TRAINING PROGRAMME: PARALEGAL TRAINING AND COMPETITION, 2023

Under 'Project Neev', we organised the '2nd edition of NLIU-LAC Workshop and Training Programme' from April 22nd to April 23rd, 2023. The theme for this edition was 'Paralegal Training and Competition'. The objective was to provide a step-by-step guide to set up and run a legal aid clinic, primarily to the institutions in MP. The opening ceremony of the event was graced by prominent legal experts and scholars who delivered meaningful speeches on the subject. Over 90 students and faculty members from 20 law colleges and universities participated, making the programme a huge success.



13.1 DAY 1 - PARALEGAL TRAINING

SESSION 1

NLIU-LAC conducted the first Training Session focused on <u>'Enhancing Access to Justice'</u>. The session was led by our esteemed chief guest, Dr. PC Kothari, who shed light on various key points that are crucial for the successful operation of such clinics. The session emphasized the importance of a well-defined research model and core activities. It emphasized the critical role of faculty coordinators and student members of the Clinic working in coordination.

The training session also touched upon the various team-building strategies and initiatives that could be undertaken to increase the reach of the clinic, like legal aid awareness drives in nearby areas, establishing a helpline number for the clinic, posting actively on social media, collaborating with the government organizations and local NGOs, and news updates of the clinic in local newspapers. It was emphasized that a proper structure like a physical clinic, financial and administrative support from the university, possibility of obtaining sponsorships, must be in place to ensure the effective delivery of legal assistance.

SESSION 2

The Chief Guest of the second paralegal training session was Mrs. Giribala Singh, who along with the founders of the Clinic - Mr. Hussain Ali and Mr. Rishabh Halwai talked about 'Setting up and Effectively Running a Legal Aid Clinic'. She opened the session with a short speech on the nature and importance of pro bono work, the need for a holistic approach and the importance of dispute resolution in family disputes. The role of ADR mechanisms was discussed in the context of pro bono work. Lastly the need of modernization of courts and the use of technology, such as the COVID online portal for connecting with the police for assigning case managers, was also emphasized. She shared that the Clinic's Project Saarthi has been widely appreciated.



SESSION 3

The session was led by our esteemed chief guest Mr. Prasidh Raj Singh (Faculty, National Judicial Academy) on the topic of 'Client Handling, and Research and Drafting of a Legal Opinion'. The speaker, inter alia, explained the importance of the time limit where the session should not exceed more than 20 minutes at a stretch as it would lead to the loss of important information. Additionally, there should not be any emotional attachment with the client as it would defeat the purpose of the whole session. The speaker talked about 'Client Screening Process' and laid down its importance. It is upon the counsel to decide whether to accept the case or not. He said it is very important to be very honest with the client.

13.2 DAY 2 - PARALEGAL COMPETITION

The Preliminary round of the Paralegal Competition were held on April 23rd, which witnessed an incredible showcase of legal talent from various law schools across Madhya Pradesh. The competition aimed to provide a platform for the participating teams as counsels to redress the grievances of clients and offer legal advice. 20 teams from around the state showcased their sharp legal acumen and exceptional teamwork. The counsels discussed pre-litigation remedies and explained mediation to the clients in layman's terms. The interaction between the counsels and clients was noteworthy, with the teams making sure that their client's concerns were heard and addressed.



The event ended with the valedictorian ceremony where all the winners were awarded with trophies and cash prizes upto Rs. 21,000. It was inaugurated by Dr. GR Raghavender (Retd.) Joint-Secretary, Department of Justice, Ministry of Law and Justice, Govt of India, who stressed the importance of paralegal volunteers in helping the needy and shared anecdotes from his personal career. Mr. Kapil Duggal and Mr. Prasidh Raj Singh also addressed the audience congratulated fellow participants. The conference concluded on a high note, with participants sharing their positive experiences and expressing their interest in legal aid work for the benefit of society. The success of this event has set the tone for more such programmes in the future, bringing together legal aid clinics from across the country to share best practices and work towards a better future for all.



14. NLIU-LAC FOUNDATION DAY CELEBRATION

NLIU-LAC was established on 11th April 2018 and completed its five years in this academic session. A small celebration took place at the NLIU-LAC Office as we mark 5-years of the Clinic, along with our student members and faculty-in-charge Prof. Dr. Uday Pratap Singh on 11th April 2023.



15. PROJECT PUKAAR REPORT

NLIU-LAC is elated to announce the release of the Fourth Project Pukaar Report. The theme of the this report is 'Communalism, Misinformation and Social Media'.

The report discusses the impact of misinformation on social media and its role in fuelling ethnic tensions and communal riots. Drawing on the statistical data on the widespread use of social media in India and increased internet penetration, the Report takes a look at the extant legal provisions dealing with hate speech. The report also highlights responsibility of individuals in curbing misinformation by being vigilant and exercising caution.



16. NLIU LEGAL AID PROGRAMME

In order to step up the culture of community service and bring it at par with other cocurricular activities, we submitted the proposal for implementation of NLIU Legal Aid Programme. The proposal is currently under consideration of the Internal Quality Assessment Cell (IQAC) of the University.
