
Subject: ADHERENCE TO TERMS AND CONDITIONS OF NOC BY WTG OPERATORS.

The undersigned is directed to refer to this Ministry's OM of even number dated 1st August, 2018 and Ministry of New & Renewable Energy's Circular No.231/7/2018-Wind dated 18th October, 2018 on the above mentioned subject. Most of the Wind Power Projects are located within the states of Gujarat & Rajasthan, close to International Boundary. Non installation of Supervisory Control & Data Acquisition (SCADA) based remote control at Air Force Stations may lead to an undesirable situation during contingency/operational activation.

2. In view of the above, it is requested to ensure compliance of instructions issue vide Ministry of New & Renewable Energy's Circular No.231/7/2018-Wind dated 18th October, 2018 to WTG operators for installation of SCADA based remote control at nearest Air Force Stations. The WTG operators may be impressed upon the need for the installation of remote control & formulation of Standard Operating Procedure for switching off the WTGs during contingency/operational activation. The following WTG operators may be asked to contact Chief Operations Officer of the nearest Air Force Station for the said purpose:
