## Report of the Committee Constituted for evaluating the applications received in the Ministry of New and Renewable Energy for compassionate appointment

The Committee for considering of the cases of Compassionate Appointment in the Ministry of New & Renewable Energy was constituted vide MNRE's Order No. 25/17/2017- Admin-I Part(I) dated 29<sup>th</sup> August, 2022 (Annexure-1). The composition of Committee is as follows:

i. Shri Sandeep Mukherjee, Deputy Secretary : Chairman

ii. Shri Kailash Chand, Deputy Secretary : Member

iii. Ms. Sunita Dhewal, US : Member

- 2. The Committee met on 22.09.2022 and 23.09.2022, and considered the 09 applications received by Ministry of New & Renewable Energy for compassionate appointment. Out of the nine applications received by the MNRE, one application namely from Smt.Geeta daughter of Late Shri Chhatar Pal is found to be incomplete as the supporting documents affidavits have not been attached/provided. Therefore, the Committee could not evaluate the said application.
- 3. The Committee, therefore, scrutinized the remaining eight applications in response to the Ministry of New & Renewable Energy's O.M. dated 21<sup>st</sup> June, 2022 (Annexure-2) and awarded points based on the criteria/parameters mentioned in the said O.M. As per the said O.M each application is required to be evaluated in terms of the total of 100 points. In addition to the above, cases where the wife of deceased official has applied for compassionate appointment for herself, she shall get 15 additional points as grace points.
- 4. The breakup of these 115 points is as under:
  - a) Family Pension/ Monthly amount (Excluding DA & Allowance)-20 points
  - b) Terminal Benefits (DCRG, GPF/ PPF, LIC/ PLI, Leave encashment etc.)/ Lump sum amount under NPS etc.- 10 points
  - c) Annual income of earning Members and income from property-10 points
  - d) Movable/immovable property-10 points
  - e) Left over service of deceased- 15 points
  - f) Number of Dependents i.e. Mother or Father, Spouse (Wife) only- 10 points
  - g) Unmarried daughters-10 points
  - h) Dependent minor children-10 points

- i) Unmarried major son (upto 25 years of age) and Dependent major son i.e., physically & mentally challenged (without age limit)-05 points
- j) If wife of the deceased has applied for compassionate appointment for herself- 15 point
- 5. In so far as, the 04<sup>th</sup> criteria of 10 points i.e. the value of 'Immovable property' the Committee relied on the circle rates/cost of the dwelling unit of the relevant area in evaluating the value of the property. Based on the application and other papers, the points awarded to each of the eight eligible applicants is shown as per Annexure-3. For quick reference the points awarded by the Committee in respect of each applicant is reproduced below: -
