Sub: Time-extension to Solar PV/ Solar PV-wind hybrid power projects bid out on or after 10.04.2021-reg.

Madam / Sir,

Solar PV Power Developers / Associations have represented to MNRE that there is a supply chain disruption in solar PV sector and have requested for appropriate reliefs to tackle the same.

2. This issue has been examined in the Ministry and it has been decided that MNRE's Renewable Energy Implementing Agencies (SECI/NTPC/NHPC) may extend the Scheduled Commissioning Date (SCD) till 31.03.2024 (and commensurately extend other associated intermediate milestones) of such Solar PV / Solar PV-wind hybrid power projects wherein the last date of bid submission was on or after 10.04.2021 and whose SCD (including time-extensions already granted, if any) is before 31.03.2024, and who wish to avail such time-extension. This extension would not be available to those projects where the PPA has not been signed before 1st October 2022 as such projects would most likely be having their SCD beyond 31st March 2024.
