

**ORDER**

**Subject: Constitution of Project Appraisal Committee under Intra-State Transmission System Green Energy Corridor Phase-II scheme**

This is with reference to the MNRE sanction order no. 367-12/1/2022-GEC regarding “Implementation of the scheme Intra-State Transmission System Green Energy Corridor Phase-II”. In accordance with para 5.4 of the scheme guidelines annexed to the above mentioned sanction order, a Project Appraisal Committee (PAC) has been constituted under the scheme, as under:

- a. Joint Secretary / Scientist ‘G’ in-charge of GEC, MNRE - Chairperson
  - b. Chief Engineer (Power System Planning & Appraisal-1), CEA - Member
  - c. Chief Engineer (Power System Project Monitoring), CEA - Member
  - d. Director (Projects), POWERGRID - Member
  - e. DS/Director/Scientist 'D'/Scientist 'E'/Scientist 'F', GEC, MNRE - Member Secretary
2. The respective States may be invited based on the issues detailed in the Agenda of the meeting of the PAC. Further, IFD (MNRE) would be invited to those meetings of the PAC when any quantity variation proposal is considered.
3. The mandate of the Committee would be as follows:
- a. Evaluate and recommend the proposals on intra-state transmission infrastructure being set up by State Govt. implementing agency for central financial assistance in accordance to the scheme guidelines of InSTS GEC-II, including revision in the project components.
  - b. Evaluate and recommend the proposals of the States regarding extension of commissioning timeline/schedule of the projects under InSTS GEC-II scheme.
  - c. Any other issue related to the context, as felt appropriate by the Committee.
4. This issues with the approval of the Secretary, MNRE.




