4. The bidder must separately mention the monthly cost of providing the Resident Engineer for each engineer separately on its letter head to be uploaded by the vendor with ATC document.

5. The 175 nos. of Desktop computers of HP OEM as mentioned in S. No. 1 of the bid is under warranty. The bidder should quote the price for day to day maintenance of these items. Besides, it would be responsibility of the service provider to get these assets repaired by the OEM, if any part replacement is required.

6. The participating bidder must submit back to back support with bid specific OEM authorization/MAF from HP only. The document should be ink signed and stamped submitted to the Office physically before the last date of submission of the bid failing which the bid is liable to be rejected.
