- 1. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

#### 2. Generic

**Manufacturer Authorization:** Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

#### 3. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

#### 4. Service & Support

Dedicated /toll Free Telephone No. for Service Support : BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

#### 5. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

#### 6. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- 1. The period of contract may be extended for a further period of one more year upon satisfactory perform ance and mutual agreement.
- 2. 06 nos. of Color Mid-Range Photocopier, 01 no. of Color High-Range Photocopier and 02 nos. of Mono Hig h-Range Photocopiers are under Warranty till January, 2024. These machines shall be covered under AMC only after expiration of the warranty and the AMC bills for these machines shall be generated for period aft er expiry of warranty.
- 3. The supply of consumables of the photocopier machines are within purview of the AMC Service provider, it is clarified that the consumables include the supply of toner cartridges as well.
- 4. The AMC Service provider shall keep at least one set of toner cartridge for each model of machine in sto re of this Office for its readily availability. However, in any case, the service provider shall ensure that if th e toner cartridge request is received in the forenoon, the cartridge should be replaced in the afternoon of the same day and if the request is made in the afternoon, the replacement should be provided in forenoon of the next day.
- 5. The photocopier machines are connected to the local network. The AMC service provider shall also resp onsible for installation of necessary drivers on PC for taking print out and scanning through PC of the local network. The service provider has to send an engineer whenever such a request is received from the Minis try. The service provider shall not deny to provide such service on account of the fact that a system was pr eviously connected to a photocopier machine.
- 6. Bidder must not be blacklisted/terminated/debarred from any Govt. organization in the past.
- 7. Bidder must submit Bid specific OEM Authorized Service Provider authorization by Kyocera.

# Disclaimer/अस्वीकरण

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
