

## CHAPTER 13

### INDIA'S LEADERSHIP IN G20

#### 13.1 India assuming the G20 Presidency from Indonesia

India assumed the G20 Presidency from Indonesia on December 1, 2022. The Energy Transitions Working Group (ETWG), one of thirteen Working Groups under the G20, discusses energy security, accessibility and affordability, energy efficiency, renewable energy, innovation, technology, and funding. Ministry of New and Renewable Energy along with the Ministry of Power, the Ministry of Petroleum and Natural Gas, the Ministry of Coal, the Ministry of Mines, and NITI Aayog participated in the discussions and negotiations under the ETWG with representatives from the G20 and nine invitee countries.



13.2 Six key priority areas were identified under ETWG during India's G20 presidency:

- (i) Energy transitions through technology gaps
- (ii) Low-cost financing for energy transitions
- (iii) Energy security and diverse supply chains
- (iv) Energy efficiency, industrial low carbon transitions, and responsible consumption
- (v) Fuels for Future (3F)
- (vi) Universal access to clean energy and just, affordable, and inclusive energy transition pathways

Five of the above-mentioned priority areas (i, ii, iii, v and vi) were led by the Ministry of New and Renewable Energy.

13.3 To provide the framework for discussions during ETWG sessions and bring forth in-depth issues linked to priority areas, following six studies on various aspects of Priority Areas were done in partnership with International Organizations and Think Tanks:

- (i) Low-Cost Finance for the Energy Transition
- (ii) Developing Resilient Renewable Energy Supply Chains for the Global Clean Energy Transition Report
- (iii) Accelerating Green Hydrogen Production and Use
- (iv) Decentralized Renewable Energy for SDG7: A Compendium of Global Good Practices
- (v) Supporting the Energy Transition by Addressing Electrolyzer Technology Gaps
- (vi) Solar Energy Roadmap for Universal Energy Access

- 13. 4** To discuss on the agenda and identify action on above six priority areas, four working group meetings and a ministerial meeting were organised under the Energy Transition Working Group, as listed below:

The meetings were attended by around 150 delegates from G20 member countries, special invitee countries, and international organizations such as IEA, IRENA, World Bank, ADB, CEM-MI, UNIDO, UNEP and WEF.

- (i) Promoting solar energy for universal energy access
- (ii) DRE applications for achieving SDG7 goals
- (iii) Low-cost finance for new and emerging Energy technologies
- (iv) Green Hydrogen -Accelerating Net-Zero Pathways
- (v) Harnessing Offshore Wind for Accelerating Energy Transition: The Way Forward
- (vi) Diversifying Renewables and critical minerals supply chains to advance energy transitions

- 13. 6** To show case India's progress in renewable energy sector, MNRE also organized site visits/excursions to Pavagada Solar Park during ETWG -1 and Modhera, India's first solar powered village during ETWG -2 to see firsthand India's push towards renewables and efforts to mitigate climate change and also three short video films were also prepared in the field of Indian Renewable Energy and screened before G20 deliberations during the meetings

- i. Possible Renewable Energy Targets for 2030
- ii. High Level Principles for Hydrogen
- iii. Green Hydrogen Innovation Centre
- iv. Low-cost finance for new and emerging Energy technologies

India hosted the 18th G20 Summit on September 9-10, 2023, at New Delhi's iconic Bharat Mandapam, where G20 leaders met under the theme 'Vasudhaiva Kutumbakam' during the summit, sessions on 'One Earth' 'One Family' and 'One Future' were chaired by the Hon'ble Prime Minister of India and the historic New Delhi Leader's Declaration was adopted.

The major priority areas pursued by MNRE during the ETWG under India's G20 presidency have all been included in the Leader's Declaration and are reflected under the para 38, "Implementing Clean, Sustainable, Just, Affordable & Inclusive Energy Transitions in the G20 New Delhi Leader's Declaration 2023 and the same are summarized below:

- Highlighting the significance of Low-cost financing for energy transition, G20 countries agreed to work towards facilitating access to Low-cost financing for developing countries, for existing as well new and emerging clean and sustainable energy technologies, and for supporting the energy transitions in the G20 New Delhi Declaration 2023. G20 also noted the report on the "Low-cost Financing for the Energy Transitions" prepared under the Indian presidency and its estimation that the world needs an annual investment of over USD 4 trillion, with a high share of renewable energy in the primary energy mix.
- Reaffirming the importance of Hydrogen for energy transition, the G20 New Delhi Declaration 2023, Support the acceleration of production, utilization, as well as the development of transparent and resilient global markets for hydrogen produced from zero and low emission technologies and its derivatives such as ammonia, by developing voluntary and mutually agreed harmonising standards as well as mutually recognised and inter-operable certification schemes. It also affirmed the 'G20 High Level Voluntary Principles on Hydrogen', to build a sustainable and equitable global hydrogen ecosystem that benefits all nations.
- The G20 also took note of the presidency's initiative to establish the Green Hydrogen Innovation Centre steered by the International Solar Alliance (ISA).
- In the G20 New Delhi Declaration 2023, G20 members agreed to pursue and encourage efforts to triple renewable energy capacity globally through existing targets and policies as well as demonstrate similar ambition with respect to other zero and low emission technologies including abatement and removal technologies, in line with national circumstances by 2030.
- G20 also noted the 'Voluntary Action Plan for Promoting Renewable Energy to Accelerate Universal Energy Access'.

**CHAPTER 14****PROMOTION OF OFFICIAL LANGUAGE – HINDI****14.1 INTRODUCTION:**

The Ministry of New and Renewable Energy (MNRE) is committed towards promoting the use of Hindi in Official Work. With a view to accelerate the use of official language in official work and to increase awareness of employees with regard to the Official Language Policy of the Government of India, a Hindi Division has been set up in the MNRE. Its functions are as follows:

- i Translation work: Various documents of the Ministry including those to be laid in Parliament such as Parliament Questions, Parliamentary Assurances, papers related to Standing Committees and other Parliamentary Committees, Private Member Bills, Calling Attention Notices, Budget related documents, Demands for Grants, Annual Reports, Notifications, General Orders, Advertisements, Tenders, MOUs/ MOAs, Cabinet Notes, Suo Moto Statements/ Speeches and other documents received from Office of the Minister (NRE) and Office of Minister of State (NRE) and Press releases etc. are translated regularly by Hindi Division of the Ministry.
- ii Implementation of the Official Language Policy of the Union; Official Languages Act, 1963; Official Languages (Use for Official Purposes of the Union) Rules, 1976; Directions/Instructions issued by the Government from time to time regarding the use of Hindi; Annual Programme issued by the Department of Official Language, MHA every year for transacting the official work of the Union in Hindi and Presidential Orders issued on the recommendations of the Committee of Parliament an Official Language constituted under the Chairmanship of Hon'ble Minister of Home Affairs.

Presently, Hindi Division is under the administrative control of Scientist-G, a senior officer equivalent to the level of Joint Secretary, assisted by Scientist-E, Deputy Director (OL)/ Assistant Director (OL). The Hindi Division consists of one Deputy Director (OL) - (currently vacant), one Assistant Director (OL), two Senior Translation Officers, two Junior Translation Officers and two Hindi Typists. The Division monitors the implementation of Official Language Policy in the Ministry as well as in all Offices/Institutes/PSUs under its administrative control. It is playing a leading role in the direction of implementation of official language Hindi in the Ministry. The work of Official Language Hindi is progressing day-to-day as compared to the previous years and it is expected that in the near future, the Ministry will achieve maximum targets set by the Department of Official Language in the direction of implementation of OL Policy of the Government.

**14.2** During the year 2023-24, concerted efforts were made to ensure proper compliance of the provisions of Official Languages Act, 1963 and Rules framed thereunder.

**14.3** For promotion of Official Language Policy and to create more conducive environment for the officials to do more work in Hindi, various programmes and schemes are being undertaken, which include the following:

- i With a view to ensure effective implementation of Official Language Policy of the Govt. of India in the Ministry, certain check-points as per the provisions of Official Language Policy have been made and circulated for compliance. Effective steps have been taken for adherence of these check-points.

- ii Most common 100 bilingual phrases (E-Saral Hindi sentences) of the Ministry have been prepared and uploaded on the website of the Ministry.
- iii Website of the Ministry has been made bilingual and it is being updated from time to time.
- iv Hindi books are purchased in the Ministry and efforts are made to achieve the targets laid down by the Department of Official Language, Ministry of Home Affairs.
- v Addresses of Nodal Agencies have been prepared in Hindi.
- vi All documents coming under section 3(3) of the Official Languages Act 1963, including Press Releases, Tender Notices, Rules, General Orders, Notifications, Cabinet Notes, Parliament Questions and other Documents to be laid in the Parliament are presented bilingually.
- vii Letters received in Hindi are invariably replied in Hindi and Rule 5 of the Official Language Rules, 1976 is fully complied with.

**14.4** During the year 2023-24, various measures were taken for effective implementation of Official Language Policy in the Ministry. As on 31.03.2024, the percentage of Hindi correspondence with offices in regions designated as A, B and C was 78.73%, 85.28% and 84.20% respectively. Continuous efforts are being made to encourage progressive use of Hindi in official work, not only in the Ministry but also in its autonomous institutions and PSUs.

**14.5** In Order to review the progress made in the implementation of Official Language policy, quarterly meetings of Official Language Implementation Committee are held. Discussions are held on quarterly progress reports received from various Sections and Divisions of the Ministry and other organisations i.e. IREDA, SECI, NIWE, NISE and NIBE. The Sections and Divisions and other Organizations are advised to achieve the targets specified by the Department of Official Language, Ministry of Home Affairs.

**14.5** In Order to review the progress made in the implementation of Official Language policy, quarterly meetings of Official Language Implementation Committee are held. Discussions are held on quarterly progress reports received from various Sections and Divisions of the Ministry and other organisations i.e. IREDA, SECI, NIWE, NISE and NIBE. The Sections and Divisions and other Organizations are advised to achieve the targets specified by the Department of Official Language, Ministry of Home Affairs.

#### **14.6 HINDI FORTNIGHT & PRIZE DISTRIBUTION CEREMONY**

With a view to create awareness and to increase the use of Hindi in official work, Hindi Fortnight was observed in the Ministry during 14th to 29th September, 2023. Messages from Hon'ble Minister of Home Affairs, Hon'ble Minister (NRE) and Hon'ble Minister of State (NRE) regarding progressive use of Hindi were also read out. A number of competitions were held and there was active participation by officers and staff of the Ministry. As many as 34 officers and staff members belonging to Hindi and non-Hindi speaking categories were given cash awards and certificates based on their performances, by the Secretary, MNRE during the prize distribution ceremony held on October 19, 2023. Hindi Fortnight was also observed in various autonomous institutions and PSUs of the Ministry. Necessary instructions were issued to them for effective and extensive promotion and propagation of Hindi.

#### 14.7 HINDI SALAHKAR SAMITI

Hindi Salahkar Samiti of the Ministry has been reconstituted vide resolution dated 8 September, 2021. Hindi Salahkar Samiti works under the Chairmanship of Union Minister (NRE) with the main objective to advise the Ministry with regard to progressive use of Hindi in its official work.

#### 14.8 INSPECTION OF SUBORDINATE OFFICES

With a view to assess the status regarding progressive use of Official Language, inspections of all 5 offices (IREDA, SECI, NISE, NIWE & NIBE) under the administrative control of the Ministry were carried out during the year and remedial measures were suggested for compliance of Official Language Policy of the Union in their offices.
