Subject: Constitution of District Level Committee (DLC) for the Overall Management of PM-Surya Ghar: Muft Bijli Yojana at District Level.

The Government of India approved the PM Surya Ghar: Muft Bijli Yojana on 29th February 2024, aimed at installing rooftop solar plants in one crore households, with a total financial outlay of Rs. 75,021 crore. The administrative approval was granted to the scheme vide order No. 318/17/2024- Grid Connected Rooftop dated 16th March 2024. The Government of India has approved the PM Surya Ghar: Muft Bijli Yojana on 29th February 2024, aimed at installing rooftop solar plants in one crore households, with a total financial outlay of Rs. 75,021 crore.

2. In this regard, a District Level Committee for PM Surya Ghar (DLC-PMSG) is hereby constituted with the following composition:

Chairperson: District Magistrate (DM)/District Collector, of District

Members:

- a) Chief Executive Officer, Zila Parishad
 - b) Lead District Manager
 - c) Superintending Engineer(s), DISCOMs in District
 - d) District Manager, Renewable Energy Development Agency (if any)
 - e) 2 Elected Representatives from ULB/PRI's nominated by DM
 - f) 3 Non-official members nominated by Mission Directorate, MNRE
3. The State/UT government may add other relevant district level officials to the DLC for better coordination of the scheme
4. The committee may also invite any other official/non official experts for committee deliberations as it may deem fit.
5. The Committee may convene at least once every three months.
6. The DLC shall have the following terms of reference:
- a. Regularly undertake review of progress under the Scheme under all components from concerned departments
 - b. To facilitate necessary coordination between departments for implementation of the scheme

- c. To particularly review the status of rooftop solar installation in government buildings and to monitor and supervise implementation of action plan for saturation of all government buildings in a time-bound manner.
 - d. To facilitate convergence of efforts between departments at the field level to maximize impact of awareness, capacity building and rooftop solar installation, particularly in existing beneficiaries of other government schemes.
 - e. To coordinate with the National Program Implementation Agency (NPIA) regarding scheme implementation and to suggest measures to improve scheme implementation in the district.
 - f. To facilitate and review the implementation of Model Solar Village Component of the scheme.
7. The District Unit of the State Implementation Agency for PM Surya Ghar: Muft Bijli Yojana shall provide secretarial assistance to the DLC.
 8. This issues with the approval of Hon`ble Minister of New and Renewable Energy and Power.
