Subject: Administrative approval for supplementary budget of Rs.140 Crore for implementation of umbrella scheme of National Bioenergy Programme for duration of FY 2021-22 to 2025-26 (Phase-I)- Reg.

Sir/Madam,

I am directed to convey the sanction of the President of India for a supplementary budget of Rs. 140 crores for the implementation of the National Bioenergy Programme (NBP) under Phase-I, for the period from 01.04.2021 to 31.03.2026. With this supplementary allocation, the total outlay under Phase-I amounts to Rs. 998 crores. The National Bioenergy Programme is comprised of the following sub-schemes:


- i. **Waste to Energy Programme** (*Programme on Energy from Urban, Industrial and Agricultural Wastes /Residues*)
- ii. **Biomass Programme** (*Scheme to Support Manufacturing of Briquettes & Pellets and Promotion of Biomass (non-bagasse) based cogeneration in Industries*)
- iii. **Biogas Programme** (*Scheme to Support small and medium scale biogas projects*)

2. The proposed budget outlay for the sub-schemes of the National Bioenergy Programme, in respect of the additional budget sanction, which is fungible between the scheme components is detailed below:

Sub-schemes	Budget outlay of Phase-I in respect of additional budget (in Rs. Crore)
Waste to Energy Programme	37.5
Biomass Programme	52.5
Biogas Programme	50
Total	Rs. 140 Crore

3. The guidelines, implementation framework, and terms & conditions for the sub-components of the *National Bioenergy Programme* shall continue to be applicable as prescribed under Phase-I of the Programme, along with any subsequent amendments issued from time to time under the respective components.


