Various parameters related with the data entry work are as given below:-

Digitization:-

- a) The Bidder has to digitize approximate 1,75,000 Schedules of 12 pages each having 528 approximately keystroke in the schedules of District Level Household Survey. The schedules are available in hard copies with the department of Planning and Statistics in 3 languages i.e. Gujarati, Hindi and English.
- b) The bidder has to digitize all the schedules in English language on a portal developed by U.T. Administration of DNH & DD or in Excel format as per Annexure-3.
- c) Digitization of District Level Household should be in English Language and work should be done at centre identified by the competent authority in the Districts of Dadra & Nagar Haveli and Daman.

General Terms and Conditions:-
