

NOTICE INVITING SEALED QUOTATION FOR HARVESTING / SALE OF MANGO FRUITS

Sealed quotation are hereby invited from the interested parties up to 11:00 AM on 23/04/2021 at for harvesting/ sale of Mango fruits in the Government Seed Multiplication Farm, Kachigam, Nani Daman, during the harvesting season for the year 2021-22.

TERMS AND CONDITIONS:-

1. The upset price for the bid is ₹. 61,190/- (**Rupees Sixty One Thousand One Hundred Ninety Only**) the intended Bidders are required to bid above the upset price.
2. The Bid/Quotation shall be submitted as per Quotation form (as enclosed) and submitted in the name of Joint Secretary (Agriculture) Agriculture Office, Fort area, Moti Daman in a sealed cover super scribed as "Quotation for sale of Mango Fruits."
3. The Mango Orchard will be open for the inspection by the interested person(s) between 10:00 Hrs to 17:00 Hrs on any working day, however, with prior permission of the I/c of Govt. Agriculture Farm, Kachigan, Nani Daman, The I/c of Govt. Agriculture Farm, Kachigan, Nani Daman, has authority to deny such permission for the reasons not to be explained to the interested person (s).
4. No any kind of damage shall be caused to the trees and other property of the Farm. In case of any such damage, the successful bidder has to compensate the same as per instructions of the I/c of Govt. Agriculture Farm, Kachigan, Nani Daman, failing which, the bidder will not be allowed to continue the harvesting of Mango Fruits. The Government shall not be responsible for the damages occurred to the Bidders on account of the discontinuation of harvesting. If required, his EMD lying with Department will also be forfeited to the Government in order to recover the losses occurred to Government.
5. The bidder should ensure that he has to follow all the guideline of Covid -19 and others instructions issued by the Govt. of India / U.T. Administration from time to time.
6. The bidder is himself responsible for transport the harvested fruits the farm through labours / vehicle including obtaining vehicle permission etc. from the competent authority.
7. The bidders should submit the copies of the Aadhaar Card alongwith copy of Address Proof.
8. The bidder should enclose EMD Of ₹. 3000/- (**Rupees Three Thousand Only**) in the form of FDR/ Demand Draft/ Cheque drawn in the favour of the Joint Secretary, Agriculture, Daman of any Nationalized /Scheduled Bank. Quotation submitted without EMD shall be summarily rejected.
9. The highest Bidder has to pay full amount of bid through Cheque / Demand Draft/ POS machine etc. within five working days from the date of issue of latter regarding intimation of highest bidder for harvesting of Mango fruit otherwise the quotation will be rejected and the EMD will be forfeited to the Government and may be offered to Second highest bidder.
10. The successful bidder will have to pay within 5 days from the date of demand an amount equal to 10% of the total value of the bid amount as Performance Guarantee in the form of FDR/ Demand Draft/ Cheque drawn in the favour of the Joint Secretary, Agriculture, Daman for any Nationalized /Scheduled Bank valid up to the period of three months from date of issuing order.
11. Department will not be responsible/ compensated for any damage / loss cause to the successful bidder due to any natural calamity or accidental fire.
12. The harvesting /grading /transportation / sale of fruits is allowed on all working days during working hours till the end of harvest season at the responsibility & cost of successful bidder.
13. The Bidder should ensure that harvesting of Mango fruit should be completed within 2 (Two) months from the date of issue of authority letter of harvesting Mango fruit and no more time limit is to be granted beyond the 2 (Two) months.

The sealed quotation will be opened on 23/04/2021 at 03:00 PM in the presence of the Members of the Committee constituted for the purpose of the quotation or their representatives, if any possible.
15. Assigning of any tree or trees in the orchard to other parties, by any mean, by the successful Bidder is not allowed under any circumstances.
16. The right to accept or reject all quotations, without assigning any reason thereof, is reserved with the Joint Secretary, Agriculture, Daman.
