Whereas, it appears to the appropriate Government that a total of 139.00 Sq. Mtrs. land is required in Diu District, namely **Land Acquisition for development of Pensao Beira Mar into Heritage Hotel in Diu District**, for public purpose as defined in Section 2(1) (vi) of the RFCTLARR Act, 2013.

2. It is notified that for the above said project in Diu District, a piece of land admeasuring **139.00 Sq. Mtrs.** of standard measurements is required. Details of the land acquisition is enclosed as **Annexure-I**.

**WHEREAS**, vide Preliminary Notification No. MAHSRP/Addl./16/2019/15/Rev(S)/2021 dated 11.01.2021, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of **Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR)**.

**WHEREAS**, a report was submitted to the Appropriate Government i.e. Hon'ble Administrator, Daman & Diu and Dadra & Nagar Haveli to proceed with acquisition process and the same has been approved by the Appropriate Government i.e. Administrator of Daman & Diu and Dadra & Nagar Haveli.

**WHEREAS**, vide Declaration No. LAQ/MAHSRP/Addl./16/2019/349 dated 05.06.2021, it was declared under the provision of Section 19 of the Land Acquisition and Rehabilitation Act that the said lands are required for the public purpose, and namely for the purpose of Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR).

**WHEREAS**, in connection with acquisition of land admeasuring 810 sq.mtrs. for Construction of Infrastructure project of Mumbai-Ahmedabad High Speed Rail Project (MAHSR), the Administration of Dadra and Nagar Haveli intends to take possession of land, the particulars of which are given in the declaration u/s 19(1) of the Right to Fair compensation & Transparency in land Acquisition Rehabilitation and Resettlement (RFCTLARR) Act, 2013.

- g) Prepare a detailed road map for activities to build awareness and outreach among public on plastic waste management and reduction in the use of SUP items.
