Filling up of the post of President in the District Consumer Disputes Redressal Commission (District Commission), Dadra & Nagar Haveli and Daman & Diu.

Applications are invited from suitable candidates for appointment to the post of President and Two Members (At least one member or the President of the District Commission shall be woman) of part time basis in the District Consumer Disputes Redressal Commission (DCDRC), Dadra & Nagar Haveli and Daman & Diu.

- 2. In terms of the Consumer Protection Act, the UT. Administration of Dadra & Nagar Haveli and Daman & Diu has to establish the District Consumer Disputes Redressal Commission at District level. It adjudicates consumer complaints relating to defective good, deficient services, including unfair/restrictive trade practices where the value of the goods or services paid as consideration does not exceed rupees one crore. The District Commission consists of a President and not less than 2 Members (At least one member or the President of the District Commission shall be woman).
- 3. It is now proposed to fill up the post of President and Member of the DCDRC in terms of the provisions of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, terms of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020.

4. ELIGIBILITY CRITERIA (FOR PRESIDENT & MEMBER OF DCDRC)

In terms of Rule-4 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020 made by Central Government in exercise of the powers conferred by section 29 and 43, read with clauses(n) and (w) of sub-section (2) of section 101 of the Consumer Protection Act, 2019 (35 of 2019).



Qualification for appointment of President and Member of District Commission:

- (1) A person shall not be qualified for appointment as President, unless he is, or has been, or is qualified to be a District Judge.
- (2) A person shall not be qualified for appointment as a Member unless he
 - (a) is of not less than 35 (Thirty Five) Years of Age.
 - (b) Possesses a bachelor's degree from a recognized University; and
 - (c) is a person of ability, integrity and standing, and having special knowledge and professional Experience of not less than **fifteen years** in Consumer Affairs, law, public affairs, administration, Economics, Commerce, Industry, Finance, Management, Engineering, Technology, Public Health or Medicine.
- (3) At least one Member or the President of the District Commission shall be women.

DISQUALIFICATIONS for appointment of President and Member of District Commission:

A person shall be disqualified for appointment as President or a Member of a State Commission or District Commission if he -

- (1) has been convicted and sentenced to imprisonment for an offence which involves moral turpitude; or
- (2) has been adjudged to be insolvent; or
- (3) is of unsound mind and stands so declared by competent court; or
- (4) has been removed or dismissed from the service of the State Government (UT. Administration of Dadra & Nagar Haveli and Daman & Diu) or Central Government or a body corporate owned or controlled by such Government: or
- (5) has, in opinion of the State Government (UT. Administration of Dadra & Nagar Haveli and Daman & Diu), such financial or other interest as is likely to prejudicially affect his functions as the President or Member.

6. TENURE: (FOR PRESIDENT & MEMBER OF SCDRC):

The President and every Members of the State Commission and District Commission shall hold office for a term of **four years** or up to the age of sixty-five years, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty five years and such reappointment is made on the basis of the recommendation of the Selection Committee.

7 REMUNERATION

- 1. President of the State Commission shall be paid remuneration of Rs.500/- per sitting
- Members of the State Commission shall be paid remuneration of Rs.400/- each Member per sitting

8. OATHS OFFICE AND SECRECY

Every person appointed to be the President / Member shall, before entering upon his/her office, make and subscribe an oath of office in Form-I and oath of secrecy in Form-II annexed to these rules.

- 9. Applications of eligible candidates, willing to be considered for the post of President in the District Commission in the attached proforma may be sent to Joint Secretary, Food & Civil Supply/ Consumer Affairs, Collectorate, Dholar, Moti Daman 396 220., so as to reach by 25/09/2021. Applications which are incomplete or lacking in any details/documents as asked for or which are received after the due date 25/09/2021 shall not be entertained and will be rejected summarily.
- In case of retired applicants, date of superannuation will be necessary from the last employer.
- 11. Persons who are selected for appointment would have to resign/take voluntary retirement from the post being held at that time, before taking up his appointment. The appointment of selected candidates shall be subject to his /her production of a certificate of medial fitness duly signed by a Civil Surgeon or District Medical Officer in the prescribed proforma Form-III.
- 12. The persons selected for appointment will have to join within 60 days from the date of issue of appointment order.
- 13. The Secretary, Food & Civil Supplies/ Consumer Affairs, Secretariat, Vidhyut Bhawan, Kachigam, Daman reserves the right to cancel the advertisement at any time without assigning any reasons.
- 14.
