NOTIFICATION

In exercise of the powers conferred by the provision to Article 309 of the Constitution read with Govt. of India, Ministry of Home Affairs letter No.U-14012/13/2012-CPD dated 1st February, 2016 and in supersession of the existing Recruitment Rules for the posts, and all other powers enabling him in this behalf, the Administrator of Dadra & Nagar Haveli and Daman & Diu, is hereby pleased to make the following rules regulating the method of recruitment to Group 'A' Gazetted, Non-Ministerial posts of **Public Health Dentist / Dental Surgeon,** in the Directorate of Medical and Health Services, U.T. Administration of Dadra & Nagar Haveli and Daman & Diu namely:-

1. SHORT TITLE AND COMMENCEMENT -

- (i) These rules may be called the Administration of Dadra and Nagar Haveli and Daman and Diu, Directorate of Medical & Health Services, **Public Health Dentist**/ **Dental Surgeon**, (Group 'A' Gazetted / Non-Ministerial) posts Recruitment Rules, 2021.
- (ii) They shall apply to the posts specified in column-1 of the schedule to these rules.
- (iii) These rules will come into effect from the date of publication of this notification in the official Gazette and will related to the appointment to the various posts made on or after this date.

2. NUMBER OF POST, CLASSIFICATION AND LEVEL IN THE PAY MATRIX

- The number of the said post, its classification and the level in the pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules. Provided that, the Administrator of Dadra & Nagar Haveli and Daman & Diu may vary the number of posts in column 2 of the said schedule from time to time subject to exigencies of work.
- 3. METHOD OF RECRUITMENT, AGE LIMIT, OTHER QUALIFICATION ETC The method of recruitment, age limit, qualifications and other matters relating to the said posts shall be as specified in columns 5 to 13 of the aforesaid Schedule.

4. **DISQUALIFICATION:**

No person, (a) who has entered into or contracted a marriage with a person having a spouse living or; (b) who having a spouse living, has entered into or contract a marriage with any person shall be eligible for appointment to the said service.

Provided that, the Administrator of Dadra & Nagar Haveli and Daman & Diu may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

5. POWER TO RELAX :-

Where the Administrator is of the opinion that, it is necessary or expedient so to do, it may, by order, and for reasons to be recorded in writing and in consultation with Union Public Service Commission, relax any of the provisions of these rules with respect to any class or category of persons.

6. **SAVING**:-

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes and Scheduled Tribes, and other special categories or persons in accordance with the orders issued by the Central Government from time to time in this regard.
