NOTIFICATION

No. 7-2/EC/DNH&DD/2021: Whereas casual vacancies have occurred in Ward No. 6/8 of Kauncha Gram Panchayat, Ward No. 3/11 of Galonda Gram Panchayat in Dadra & Nagar Haveli and Ward No. 6 (Bucharwada-A) of District Panchayat Diu due to death of its members, as shown in the Annex to this notification.

Now, therefore, in pursuance of the provision of Rule 111 of Dadra and Nagar Haveli Panchayats (Election Procedures) Rules, 2014, and Rule 111 of Daman and Diu Panchayats (Election Procedures) Rules, 2014, the Election Commission for Dadra and Nagar Haveli and Daman & Diu hereby calls upon the said wards to elect a member each to fill the said vacancies in accordance with the provisions of the Dadra and Nagar Haveli and Daman & Diu Panchayats Regulation, 2012 and the said Rules and Orders made thereunder and appoints the following dates with respect to the said bye elections. It is further stated that Ward No. 6/8 of Kauncha Gram Panchayat and Ward No. 3/11 of Galonda Gram Panchayat are reserved for Scheduled Tribes and Ward No. 6/8 (Bucharwada-A) of District Panchayat Diu is reserved for General Women.

- (a) the 28th September, 2021 (Tuesday) between 11.00 a.m. and 3.00 p.m., as the last date and hours for making nominations;
- (b) the 29th September, 2021 (Wednesday) 11.00 a.m., office of the respective Returning Officer, as the date, time and place for scrutiny of nominations;
- (c) the 1st October, 2021 (Friday) 3.00 p.m., as the last date and hour for the withdrawal of candidatures;
- (d) the 17th October, 2021 (Sunday) between 8.00 a.m. and 5.00 p.m., as the date on which and the hours during which the poll shall, if necessary, be taken;
- (e) the 20th October, 2021 (Wednesday) from 8.00 a.m. onwards, as the date on which and the time during which the counting of votes shall be taken and
- (f) the 22nd October, 2021 (Friday) as the date before which the election shall be completed.
