Filling up of the post of President and Members in the State Consumer Disputes Redressal Commission (State Commission), Dadra & Nagar Haveli and Daman & Diu.

Applications are invited from suitable candidates for appointment to the post of President and Members (At least one member or the President of the State Commission shall be woman) of part time basis in the State Consumer Disputes Redressal Commission (SCDRC), Dadra & Nagar Haveli and Daman & Diu.

- 2. In terms of the Consumer Protection Act, the UT. Administration of Dadra & Nagar Haveli and Daman & Diu has to establish the State Consumer Disputes Redressal Commission at State/ UT level. It adjudicates consumer complaints relating to defective good, deficient services, including unfair/restrictive trade practices where the value of the goods or services paid as consideration exceeds rupees one crore, but does not exceed rupees ten crore. It also hears appeals against the orders of District Consumer Disputes Redressal Commission within the State/UTs. The State Commission consists of a President and not less than 4 Members(At least one Member or the President of the state Commission shall be woman).
- 3. It is now proposed to fill up the post of President and Members of the SCDRC in terms of the provisions of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, terms of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020.

4. ELIGIBILITYCRITERIA (FOR PRESIDENT AND MEMBER OF SCDRC)

In terms of Rule-3 of the Consumer Protection (Qualification for appointment, method of recruitment, procedure of appointment, term of office, resignation and removal of the President and Members of the State Commission and District Commission) Rules, 2020 made by Central Government in exercise of the powers conferred by section 29 and 43, read with clauses(n) and (w) of sub-section (2) of section 101 of the Consumer Protection Act, 2019 (35 of 2019).

Qualifications for appointment of President and Members of the State

- (1) A person shall not be qualified for appointment as President, unless he is, or has been, a Judge of the High Court:
- (2) A person shall not be qualified for appointment as a Member unless he is of not less than 40 (forty) years of Age and possesses.
 - (a) An experience of at least 10 years as presiding officer of a district court or of any tribunal at equivalent level or combined service as such in the district court and tribunal.

Provide that not more than fifty percent of such members shall be appointed; or

- (b) A Bachelor's Degree from a Recognized University and is a person of ability, integrity and standing and has special knowledge and professional experience of not less than twenty years in Consumer Affairs, law, public affairs, administration, Economics, Commerce, Industry, Finance, Management, engineering, Technology, Public Health or Medicine.
- (3) At least one member or the President of the State Commission shall be a woman.
- 5. DISQUALIFICATIONS for appointment of President and Member of State Commission:

A person shall be disqualified for appointment as President or a Member of a State Commission if he -

- (1) has been convicted and sentenced to imprisonment for an offence which involves moral turpitude; or
- (2) has been adjudged to be insolvent; or
- (3) is of unsound mind and stands so declared by competent court; or
- (4) has been removed or dismissed from the service of the State Government (UT. Administration of Dadra & Nagar Haveli and Daman & Diu) or Central Government or a body corporate owned or controlled by such Government: or
- (5) has, in opinion of the State Government (UT. Administration of Dadra & Nagar Haveli and Daman & Diu), such financial or other interest as is likely to prejudicially affect his functions as the President or Member.

6. TENURE:(Term of Office of President or Member):

The President and every Members of the State Commission shall hold office for a term of **four years** or upto the age of sixty-five years, whichever is earlier and shall be eligible for reappointment for another term of four years subject to the age limit of sixty five years and such reappointment is made on the basis of the recommendation of the Selection Committee. However, the above State Commission would look after cases of all the 03 Districts namely Dadra & Nagar Haveli, Daman and Diu.

7 REMUNERATION

- 1. President of the State Commission shall be paid remuneration of Rs.600/- per sitting
- 2. Members of the State Commission shall be paid remuneration of Rs.500/- each Member per sitting

OATHS OFFICE AND SECRECY
 Every person appointed to be the President and Member shall, before entering upon his office, make and subscribe an oath of office in Form-I and oath of secrecy in Form-II

annexed to the rules.

- 9. Applications of eligible candidates, willing to be considered for the post of President and Members in the State Commission in the attached proforms may be sent to Joint Secretary, Food & Civil Supply/ Consumer Affairs, Collectorate, Dholar, Moti Daman 396 220, so as to reach by 11/02/2022. Applications which are incomplete or lacking in any details/documents as asked for or which are received after the due date 11/02/2022 shall not be entertained and will be rejected summarily.
- In case of retired applicants, date of superannuation will be necessary from the last employer.
- 11. Persons who are selected for appointment would have to resign/take voluntary retirement from the post being held at that time, before taking up his/her appointment. The appointment of selected candidates shall be subject to his/her production of a certificate of medical fitness duly signed by a Civil Surgeon or District Medical Officer in the prescribed proforma Form- III.
- 12. The persons selected for appointment will have to join within 60 days from the date of issue of appointment order.
- 13. The Secretary, Food & Civil Supplies/Consumer Affairs, Secretariat, Vidhyut Bhawan, Kachigam, Daman reserves the right to cancel the advertisement at any time without assigning any reasons.
- 14.
