NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the constitution, read with Government of India, Ministry of Home Affairs order No. 7/1/65-Estt(A) dated 16th February 1965 and Ministry of Home Affairs Notification No.3(4)/65-GP, dated 27th January, 1965 and in supersession of the existing Recruitment Rules for the posts and all other powers enabling him in this behalf, the Administrator of Dadra and Nagar Haveli and Daman and Diu hereby makes the following rules relating to the recruitment of General Central Services, Groups 'C' (Non-Gazetted/Non Ministerial) posts of **Head Constable** in the Police Department, Administration of Dadra and Nagar Haveli and Daman and Diu namely.

1. Short title, application and commencement:

- (i) These rules may be called the Administration of Dadra and Nagar Haveli and Daman and Diu, Group 'C' (Non-Gazetted/Non-Ministerial) posts of **Head Constable**Recruitment Rules, 2021.
- (ii) These rules shall apply to the posts specified in column 1 of the Schedule to these rules (hereinafter called the said schedule).
- (iii) These rules will come into effect from the date of publication of this notification in the Official Gazette and will relate to appointment to the various posts made on or after this date.
- Number of posts, classification and level in the of Pay Matrix: The number of posts, classification and the level of pay matrix attached thereto shall be as specified in columns 2 to 4 of the Schedule annexed to these rules.

Provided that, the Administrator of Dadra and Nagar and Daman and Diu may vary the number of posts in Column 2 of the said Scheduled from time to time subject to exigencies of work.

 Method of recruitment, age limit and other qualification etc.: The methods of recruitment to the said posts, age limit, qualification and other matters connected there with shall be as pacified in Columns 5 to 13 of the aforesaid schedule.

4. Disqualification:

No person (a) who has entered into or contracted a marriage with a person having a spouse, living or (b) who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the service.

Provided that the Administrator of Dadra & Nagar Haveli and Daman & Diu, may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there other grounds for so doing, exempt any person from the operation of this rule.

5. Power to relax:

Where the Administrator of Dadra and Nagar Haveli and Daman and Diu is of the opinion that, it is necessary or expedient so to do it may, by order, and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

6. Saving:

Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for Scheduled Castes, Scheduled Tribes, Other backward Class, Ex-Servicemen and other special of persons in accordance with the orders issued by Central Government from time to time in this regard.

NOTIFICATION

In view of the amendment in the Recruitment Rules referred to above, wherein the post of Head Constable will be filled up by promotion from Police Constable on the basis of 75% promotion by Seniority-cum-Selection and 25% promotion by Efficiency Test, the Administrator of Dadra and Nagar Haveli and Daman and Diu is pleased to make following norms to conduct examination for promotion on the basis of Efficiency Test:-

1. Eligibility:-

(i) Police Constable having minimum 05 years of regular service in Police Department of Dadra and Nagar Haveli and Daman and Diu.

2. Committee / Agency for conducting the Efficiency Test:-

- (i) A Committee comprising of Dy. Inspector General of Police, Superintendent of Police (HQ) or Senior most Superintendent of Police, senior most Sub-Divisional Police Officer & Dy. Secretary (Home) constituted by name, **OR**;
- (ii) Staff Selection Board (SSB) of the UT Administration, OR;
- (iii) Any other Agency.

As decided by the Police Department from time to time.

3. Physical Test :-

- (i) The Physical test shall be qualifying in nature and no marks will be given for outdoor test.
- (ii) The physical test shall consist of 800 meter run for both male and female candidate within the following time duration shown against the concerned age group.

(a) For Male Candidates:-

Sr.No.	Age Group	Maximum Time duration
1	Up to 35 years	4 minutes.
2	Above 35 and upto 45 years	4 minutes 50 seconds.

(b) For Female Candidates:-

(iv) The age of the candidate will be considered as on the day Circular/Notification to conduct the Efficiency Test is issued/published.

4. Written Test.

- (i) Only eligible candidates who shall pass the physical test successfully shall be called for the Written Test.
- (ii) The written test shall consist of 50 Multiple Choice Questions; maximum duration for the test shall be 90 minutes.
- (iii) Passing criteria will 35% of total marks i.e. 17.5 marks.
- (iv) The Committee or any other mode as decided by the Police Department shall conduct examination and prepare merit list according to marks secured in written examination and declare the result as per merit. The merit list shall be valid for one year from the date of publication.
- (v) The syllabus of written test shall be as specified in Appendix A.
