**Scholarship NOTICE :2022-23**

The Ministry of Social Justice & Empowerment has called for applications from eligible students under Pre Matric SC scheme and Post Matric SC Scheme online on NSP Portal. Students studying in schools/institutions/colleges with AISHE Code/UDISE code shall be eligible for the scholarship scheme, concern school HM/Principal shall ensure eligible students apply for the scholarship on NSP portal and approve the same as per the eligibility criteria and forward to State authority for further process.

The eligibility criteria and scope of the schemes are as mentioned below:

2	Post Matric SC	<b>Group 1:</b> Degree and Post Graduation Level professional courses Rs.13500/- (Hosteller) & Rs.7000/-(Day Scholar) <b>Group 2:</b> Other professional courses leading to Degree, Diploma ,Certificate Rs.9500/- (Hosteller) & Rs.6500/- (Day Scholar) <b>Group 3:</b> Graduate and Post Graduate courses not covered under Group I & Group II Rs.6000/- (Hosteller) & Rs.3000/- (Day Scholar) <b>Group 4 :</b> All Post Matriculation (Post Class X level) non-degree courses Rs.4000/- (Hosteller) & Rs.2500/-(Day Scholar)	- Student belong to SC category having Domicile of UT of DNH&DD -SC students of who have passed the Matriculation or Higher Secondary or an higher examination of a recognized University or Board of Secondary Education will be eligible. -Annual Income upto Rs.2.50 lakh. -Students studying in institutions/colleges with AISHE Code/UDISE code shall be eligible for the scholarship scheme.

- Students should have valid functional Mobile Number, Aadhaar Number (UID), Aadhaar linked Bank Account , Income Certificate and Caste Certificate (**incase of caste certificate issued from other state the same to be certified by concern Mamlatdar of the District**)

- For accepting applications online from eligible students the institute/school/college must complete their registration form and get it verified from District/State Nodal Officer failing which the institute/school/college will not be able to verify the applications on-line.
- Those institute/Schools with valid DISE/AISHE code can only register on NSP Portal.

Compulsory documents required for scholarship schemes may be issued as follows:

**1. Income Certificate:**

**For Daman & Diu** :may be issued by concerned Secretaries of the Panchayats once the same is attested by the respective Sarpanch and countersigned by the respective Block Development Officer for village. Such certificates may also be issued by Mamlatdar.

**For DNH** : Issued by Mamlatdar.

- 2. Certificates of Scheduled Castes (SC)/Scheduled Tribes (ST)/Backward Class Certificates (OBC)/Economically Backward Class (EBC):** Issued by Mamlatdar.
- 3. Domicile Certificate** : Issued by Mamlatdar.
