- (3) The Tender Fees in the form of Demand Draft (DD) of any Nationalized or scheduled Bank in favour of "The Chief Officer, DMC, Damam". Which is non refundable.
- (4) Registration of under CPWD, State P.W.D's or MES, Railways.
- (5) GST Registration.
- (6) Pan Card.
- (7) Latest Solvency Certificate.
- (8) EPF Registration.
- (9) Last three years Income Tax return filled.
