DECLARATION

WHEREAS, vide Preliminary Notification No. 3/78/2020/LND-ACQ/2019-20/1778 dated 23/04/2021, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the lands described in the Schedule annexed with the said Notification was needed or likely to be needed for the public purpose, namely for the purpose of Acquisition of Land from Nani Daman Bus Stand, Rajiv Gandhi Setu to Hotel Presidency Junction (Additional Proposal).

WHEREAS, as required under sub section (2) of section 15 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, objection was accorded personal hearing by the Collector, Daman on 04/08/2021, and a report was submitted to the Government Authority i.e. Administration of Dadra & Nagar Haveli and Daman & Diu for the proceed with acquisition process and the same has been approved by the Appropriate Government i.e. Administrator of Dadra & Nagar Haveli and Daman & Diu.

AND WHEREAS, the UT Administration of Dadra & Nagar Haveli and Daman & Diu is satisfied on the basis of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the said land as described in the schedule hereto hereafter referred to as the said land/lands is need for the public purpose.

NOW, THEREFORE, it is hereby declared under the Provision of Section 19 of the Land Acquisition & Rehabilitation Act that the said lands are required for the public purpose, namely Acquisition of Land from Nani Daman Bus Stand, Rajiv Gandhi Setu to Hotel Presidency Junction (Additional Proposal).
