Sub: Declaration of the Popular Front of India (PFI) and its associates or affiliates or fronts as unlawful association under section 3 (1) of the Unlawful Activities (Prevention) Act, 1967 – delegation of powers conferred under Section 7 and 8 of the Act.

ORDER

Whereas, the Central Government in exercise of the powers conferred by Section 3 (1) of the Unlawful Activities (Prevention) Act, 1967 (37 of 1967), has declared the Popular Front of India and its associates or affiliates or fronts including Rehab Indian Foundation (RIF), Campus Front of India (CFI), All India Imams Council (AIIC), National Confederation of Human Rights Organization (NCHRO), National Women's Front, Junior Front, Empower India Foundation and Rehab Foundation, Kerela as unlawful association vide Notification Number S.O. 4559(E) dated 27/09/2022.

And Whereas, the Central Government, in exercise of the powers conferred by Section 42 of the aforesaid Act has directed all the powers which are exercisable by it under Section 7 and Section 8 of the said Act shall be exercised also by the State Government and the Union Territory Administration vide Notification No. S.O. 4560(E) dated 28/09/2022.

And whereas, the Central Government has conveyed approval that the State Government and Union Territory Administration may, by order in writing, direct that any power which has been directed to be exercised by it, shall, in such circumstances and under such conditions, as may be specified in the direction, be exercised by any person, subordinate to the State Government and Union Territory Administration vide Order No. 14017/4/2022-NI-MFO dated 28/09/2022.

And whereas, the Central Government has directed all State Government and Union Territory Administration to take further necessary action in the matter vide letter No. 14017/4/2022-NI-MFO dated 28/09/2022.

And whereas, the Administration of the Union Territory of Dadra & Nagar Haveli and Daman & Diu has considered the matter in detail based on the notifications, order and letter from the Central Government referred in the preamble above.

Now, **therefore**, in exercise of the powers conferred under Section 42 of the Unlawful Activities (Prevention) Act, 1967, the Hon'ble Administrator, Dadra & Nagar Haveli and Daman & Diu hereby orders that the powers which have been directed to be exercised by the UT Administration under Section 7 and 8, respectively, of the Unlawful Activities (Prevention) Act, 1967, stands delegated to the District Magistrate / Superintendent of Police of the respective districts of the UT of Dadra & Nagar Haveli and Daman & Diu within their jurisdiction.
