- 4. <u>Dingunlification</u>: No person who has entered into or contracted a marriage with a person having a spouse living or who, having a spouse living, has entered into or contracted a marriage with any person, shall be eligible for appointment to the sorvice: Provided that the Administrator of Daman and Diu and Dadra and Nagar Haveli may, if satisfied that such marriage is permissible under the personal law applicabale to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rule.

Saying: Nothing in these rules shall affect reservations, relaxaton of age limit and other concessions required to be provided for Schoduled Castes, Scheduled Tribes and other special categories of persons in accordance with the orders issued by Central Government from time to time in this reggard.
