(A) Scrutiny Report :-

The proposal of construction of revised factory building is scrutinized in context to Development Control Rules-2005 of Daman District and the scrutiny report is placed in the file for kind perusal please.

- (1) Earlier conversion permission was granted by collector Daman for industrial use vide collector order No.2/178/98-LND/5507, dated 25th January 1999.
- (2) Earlier building plan was approved on these plots vide this office letter No.5/426/188/1to6/1706/98-99/922, dated 12/03/1999
- (3) Applicant has submitted occupancy certificate from Assistant Engineer, PWD, S.D. No-I, vide letter No. PWD/DMN/SD-II/O.C./784/99-2000, dated 15/09/1999.
- (4) Applicant has submitted NOC from Dept. of Fire & Emergency Services, Daman, vide letter No. DFES/DMN/NOC-PCP/Ind./377/ADFO/2016, dated 23/06/2016.
- (5) The applicant has furnished the proof of the application made to the Coast Guard Authority, for obtaining NOC.
- (6) Proposed factory building plan submitted by the applicant is within norms regarding Coverage, F.S.I. and Set backs as mentioned belollowed.
