Remarks, if any:

1. The UT Administration of Daman and Diu had been already empanelled 04 Agencies for smooth implementation of PMKVY 2.0 Scheme.
2. All the 04 Empanelled Agencies already Accredited and Affiliated on the SMART portal and registered their Training Centre and certified themselves on “CAAF”. All the Training Centres had undergone Assessment and total 165 trainees were assessed upto the month of October, 2018.
3. The UT Administration of Daman and Diu already allotted additional target for the next quarter to the agencies namely **1). Shree Gujarat Education Trust, Surat (160 Nos.) 2.) Orion Edu. Tech (144 Nos.) 3.) M/s Mosaic Network (India) Pvt. Ltd., Indore (270 Nos.)** in their respective Job Roles. Total 574 Nos. of additional target was given to empanelled TCs and training of 198 trainees was started.
4. Total target allocated till now is 779 Nos.
5. **“Kaushalta Protsahan Karykram”** was conducted in presence of Hon’ble Administrator of Daman & Diu & DNH. In this programme the **‘Letter of Appointment’** was issued by the Hon’ble Administrator to the successful trainees.
6. **UT Level Skill Development Mission’s** decided to include additional new 13 Job Roles and Administration have floated the EoI for the same with view to increase the no. of Job Roles in the UT Administration.
7. **The Govt. ITI** has been registered as **Training Partner** and also registered **Govt. ITI, Daman as Training Centre and CAAF** was submitted for **Govt. TTI, Daman**. Total 18 new job roles are identified to implement training at these two Govt. Institute.
