WHEREAS, vide Preliminary Notification No. 3/99/LND-ACQ/2020-21/4736 dated 01/11/2022, it was Notified under section 11 of the Right to Fair compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, that the land described in the schedule hereto (thereafter referred to as the said land/lands) were needed or likely to be needed for the public purpose, namely for the purpose of Acquisition of Land for Widening of Road at Village Bhimpore, Nani Daman.
