NOTIFICATION

WHEREAS, a proposal had been received from Chief Executive Officer, District Panchayat, Diu for exclusion of certain areas of the existing Vanakbara Gram Panchayat.

WHEREAS, the Vanakbara Gram Panchayat was consulted for the exclusion of Territorial Areas on special Gram Sabha held on 19/11/2022 and creation of new Gram Panchayats from the excluded territorial areas, a resolution of which was submitted to the Block Development Officer, Diu, vide Resolution No. 01 of Special Gram Sabha, held on 19/11/2022, in which the Gram Panchayat has resolved to create a two new Gram Panchayats by excluding certain territories from present Vanakbara Gram Panchayat.

AND WHEREAS, the Administrator, UT of Dadra and Nagar Haveli and Daman & Diu, on due consideration of the above proposal and after making such inquiries as thought necessary considered the consultation of Panchayat Resolution of Vanakbara Gram Panchayat, No. 01 of Special Gram Sabha held on 19/11/2022 and proposal of the Chief Executive Officer, Diu concurring for creation of two additional Gram Panchayats from present Vanakbara Gram Panchayat.

NOW THEREFORE, after making such inquiries as deemed necessary, in exercise of his powers under clause (b) of sub-section (1) of section 6 of the Dadra and Nagar Haveli and Daman and Diu Panchayat Regulation, 2012, the Administrator of UT of Dadra and Nagar Haveli and Daman &
