Observations and Recommendations :

Previously, notice of direction was issue to the unit on dated 15/01/2016 regarding to submit application for consent to operate. The unit has submitted the same on 10/08/2016 and was inspected on 31/08/2016 and at the time of inspection following observations were noted:

- Display signboard was prepared and placed at the main gate of premises.
- The unit was in operation at the time of inspection.
- Raw material used in manufacturing process was LDPE/PP scrape material only.
- Products being manufactured at the time of inspection were Plastic reprocessed granules only.
- Manufacturing process involved at the unit was Agglomeration of scrape – Extrusion – Packing.
- Machineries installed within the premises of the unit were Agglo m/c – 1 no, Extruder m/c – 1 no, Cutter – 1 no, Cooling tower – 1 no.
- Raw materials and finished goods were stored properly within the premises.
- The unit is not significant to pollution potential as there is no water used during any stage of process and no significant emission form the process.

In view of above, Consent to Operate (Category-II) to manufacture **“Re-process plastic granules (from 1st generation in-house plastic waste only) – 3600 MT/Annum”** under Water and Air Act with terms and conditions as mentioned in Annexure-I for the period upto **31/08/2018**.
