M/s. Mahavir Flexi Pack, Village Dabhel, Daman was issued 'consent to establish' to manufacture plastic plain, printed and laminated bags (thickness above 40 microns), rolls and pouches-2200 MTPA, plastic vacume forming tray-600 MTPA, injection and blow moulding articles-200 MTPA under Water/Air Act and valid upto **30/11/2014**. The activity falls under **Green Category**. The unit has applied for grant of 'consent to operate' under Water/Air Act on 30/03/2015 and the following documents are as under:


- Application Form-XIII under Water Act.
- Application Form-I under Air Act.
- Paid consent fees of Rs. 2360/- under Water Act & Air Act.
- Self declaration letter regarding showing capital investment.
- Establishment consent copy under Water Act & Air Act.
- Application Form-I for authorization to handle hazardous wastes and industry data sheet.
- Details of display sign board.
- Form-I application for registration for manufacturing of plastic carry bags and containers.


The unit was inspected on 20/04/2015 and the observations are as under:

- The unit was in operation at the time of inspection.
- The unit is in 1<sup>st</sup> Floor, Kruti Industrial Estate, Premises No.3, Village Dabhel.
- The unit has installed machinery such as side sealing m/c-3 Nos., punching m/c, folding m/c, manual side sealing m/c-2 Nos.
- The process includes mainly by side sealing-punching-folding-packing only from ready films and rolls.
- The unit has not installed extruder i.e. tubing plant machine, vacuum forming m/c, printing m/c, injection moulding m/c, blow moulding m/c, ultra sonic welding m/c for manufacture of plastic vacume forming tray, injection and blow moulding articles at the time of inspection.
- The unit has not installed displayed sign board.
- The unit is not using any water during the process and is not significant to pollution potential.

In view of the above, if approved a letter for display sign board is prepared and placed in the file for signature pl, Sir.

M/s. Mahavir Flexi Pack, Dabhel, Daman was issue Consent to Establish for manufacturing of "(i) Plastic plain, printed and laminated bags (Thickness above 40 microns), rolls and pouches – 2200 MTPA, (ii) Plastic vacuum forming tray – 600 MTPA (iii) Injection and blow moulding articles – 200 MTPA" under the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 which was valid upto **30/11/2014**. The activity falls under **Category – III**.

Previously, the unit had submitted Consent to Operate application on 30/03/2015 and issued letter vide no. PCC/DDD/G-5814/WA/AA/DB/13-14/71 dated 24/04/2015 regarding to install display sign board in front of the gate along with details and photograph not submitted reply of the same till date to this office. Again, the unit has submitted application for grant of Consent to Operate on 25/07/2017 with following documents:

- Application form. XIII under the Water (Prevention and Control of Pollution) Act, 1974.
- Application form. I under the Air (Prevention and Control of Pollution) Act, 1981.
- Consent fees of Rs. 6540/-.
- Declaration letter for details of capital investment.
- Display signboard.
- Form – I for application for authorization to handle Hazardous Waste.
- Industry Data Sheet Format.
- Project report with details of manufacturing process and raw material.

The unit was inspected on 10/08/2017 in presence of Mr. Hiren (Accountant) and at the time of inspection following observations were noted:

- Display signboard was installed outside of the premises.
- The unit was in operation at the time of inspection.
- Raw material used in manufacturing process was PP/PE/LDPE sheets/rolls, Printing ink.
- Products being manufactured were Printed plastic sheets/bags and pouches.
- Manufacturing process involved at the time of inspection was Printing, Cutting and Sealing.
- Machineries installed within the premises of the unit were Printing – 01 no, Lamination m/c – 01 no, Cutting and Sealing m/c – 08 no, Compressor – 02 no.
- The generated plastic waste were stored within the premises and sold to recycler.
