The unit was also issued consent to establish for installation of a D.G. Set-380 KVA for stand by purpose under Air act valid upto 28/02/2017. The activity falls under Category-III.

- > Products being manufactured were plastic films and pouches.
- Manufacturing process involved in the unit was extrusion.
- Machineries installed in the unit were 3 extrusion machines, 3 chillers, 32 cooling tower and 3 compressors.
- A D.G. Set -380 KVA was found installed in the unit premises having acoustic enclosure over it for reduction of noise level and a stack attached to it having adequate height.
- > Housekeeping observed was in good condition.
- > Proper storage facilities were available for raw material and products.
- > The unit is not significant to pollution potential. As there is no water used during any stage of process.
- > The unit was availed with septic tank and soak pit for domestic waste water generation.
