Industries, Gala No. 1, Ground floor, Sr. no. 336/2 (1), Behind Cricket Ground, Village-Kachigam, Daman was issued consent to establish for manufacturing of "HM,LD & PP Tubing, Rolls-350 MTPA, HM,LD& PP Sheets, Bags (thickness above 40 microns)-150 MTPA, Printed Rolls, Sheets and Bags (thickness above 40 microns)-250 MTPA, Plastic packaging products-150 MTPA. (no other items)." (no other items). under Water and Air act valid upto 30/11/2014. The activity falls under **Green category**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 12/10/2015 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs 2360 /-.
- Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Application as per Form – I of Recycled Plastic Manufacturing and Usage (Amendment) Rules, 2003 for grant of registration for manufacturing of plastic carry bags and containers.
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

The unit was inspected on 17/12/2015 at 16:45 hrs. At the time of inspection of the unit following observations were noted:

- No display sign board was available at the entrance gate of industry.
- Representative of the unit was instructed to avail Display Sign Board at Entrance Gate of the Unit.
- The unit was in operation at the time of inspection.
- Raw materials used in manufacturing process were granules of HM, LD, & PP Granules, Master Batches,.
- Products being manufactured were plastic bags, sheets and rolls.
- At the time of inspection all the machineries were found installed and operational in the premises of the unit whom details were submitted by the unit to the PCC, Daman.
- Manufacturing process involved in the unit was extrusion, cutting, sealing, packaging and printing of above mentioned raw materials into final products.
- Housekeeping was sufficient but safety measures were not adequate as necessary.
- Representative of the Unit were instructed to avail all the employees with necessary safety equipment (gloves, goggles, safety shoes) & training related to safety precautions to reduce the risk of hazards or accidents.

- Representative of the Unit were instructed to avail posters or stickers over each of the machine with their details and take necessary safety measures to avoid risk.
- Proper storage facilities were available for raw material and products.
- The unit is not significant to pollution potential. As there is no water used during any stage of process.
- The unit was availed with septic tank and soak pit for domestic waste water generation.

Based on above observation a quarry letter had been prepared and placed for your kind perusal and approval, Sir Please.
