**CONSENT CONDITIONS UNDER AIR ACT FOR CATEGORY-III INDUSTRIES**

- 1) The applicant is required to apply in Form - XIII under Water (Prevention and Control of Pollution) Act, 1974 to obtain establish / operate / renew consent separately without which consent under Air (Prevention and Control of Pollution) Act, 1981 shall neither be issued nor renewed for establish / operate / renew respectively.
- 2) The applicant is required to provide suitable Air Pollution Control Devices so that the concentration of suspended Particulate Matter measured within the premises or in between 2 and 10 mtrs. from the process equipment shall not exceed 500 microgram/m<sup>3</sup>. Any alternation in the APCD's shall be carried out only with the prior written consent of the P.C.C.
- 3) There shall be no emission other from the installations listed in the consent order.
- 4) The applicant is required to provide sampling facilities to monitor the emission as per the Central Board's Emission Regulation Part - III.
- 5) The applicant shall provide ports in the chimney/(s) and facilitate such as ladder, platform, etc. for monitoring the air emission and the same shall be open for inspection or/and for use of the Committee Staff. The chimney/(s) vents attached to various source of emission shall be designated by number such as S-1, S-2, etc. and these shall be painted/ displayed to facilitate identification.
- 6) The industry shall take adequate measures for control of noise level from its own sources within the premises to less than 75 dB during night time. Day time is reckoned to be between 6 a.m. and 9 p.m. and night time is reckoned between 9 p.m. and 6.00 a.m.
- 7) The applicant is required to provide stack of height not less than ..... mtrs. or as per the formula given below whichever is more.  

$$H = 14(Q)^{0.3}$$
 Where Q is SO<sub>2</sub> emission in Kg./hrs  

$$H = 74(Q)^{0.27}$$
 Where Q is PM emission in T/hrs
- 8) The consent is granted to establish / operate D.G. Set as a standby arrangement only and not as a captive power generation unit.
- 9) The applicant is required to provide a stack of height not less than ..... mtrs. from roof level or 9.0 mtrs. from ground level whichever is more to the D.G. Set.
- 10) The Consumption of LDO/FO HSD shall not exceed ..... KL, where the sulphur content of LDO/FO/HSD shall not exceed the below mentioned limits.  
 The applicant is required to monitor the emission from the ..... once in a month and shall submit to the office Quarterly Analytical Test Report falling which renewal of Consent shall not be granted.
- 12) The applicant is required to submit a copy of the ..... Within 21 days from the date of issue of this letter falling which consent issued to you would be cancelled automatically without any notice on this behalf.
- 13) The applicant is required to carry out the spray painting in a well protected area.

21) Only one copy of the Application is required to be made.

20) The applicant shall submit a duly filled in compliance report in the prescribed format duly signed by the authorized signatory along with the application for renewal in Form No. XIII of Water Act and Form No.1 of Air Act at least 30 days before the expiry of the consent.

19) The applicant shall submit a duly filled in compliance report in the prescribed format duly signed by the authorized signatory along with the application for renewal in Form No. XIII of Water Act and Form No.1 of Air Act at least 30 days before the expiry of the consent.

18) The consent to operate shall be renewed only if the operator follows all the above conditions. On inspection, if any acts of commission or omission are observed the consent issued can be suspended or cancelled without further notice.

17) If sufficient land area is available the operator shall plant ornamental and shade giving plants of 3-5 varieties at 2x2 mts spacing.

16) The applicant is required to make necessary arrangements to avoid spillage of materials either in liquid or solid form and also maintain good housekeeping.

15) The applicant shall store containers/drums of chemicals and other volatile materials/substances/products in a separate chamber.

14) The applicant shall not install and any machinery other than the ones mentioned in the consent order. And also shall not exceed the permitted production capacity of each of the products except with the written consent from this office.

13) The applicant is required to submit the consent fees in the form of D.O. within 15 days from the date of issue of this order which the consent issued to stands cancelled automatically.

10) The ambient noise level generated from machinery and manufacturing process from the premises shall not exceed.

- The unit shall comply with Plastic Waste (Management and Handling) Rules 2011.
- The unit shall not carry out any type of washing.
- The unit is not permitted to manufacture plastic granules.
- The unit shall not use plastic scraps/waste as raw materials.
- The applicant shall collect and store the waste i.e. waste/used oil, plastic waste, inc residue, empty tin/containers, etc generated from the process/ plant and machinery inside the factory premises and shall maintain a separate register for recording details such as generation, disposal, name of the recycler/ re-processor to whom sold etc.
- The applicant shall sell or auction hazardous waste (i.e. waste/used oil, plastic waste, inc residue, empty tin/container, etc) only to registered re-processor or recycler who undertake to re-refine or recycle the waste within the period of validity of his certificate of registration.
- The applicant shall not dispose off the hazardous waste (i.e. Plastic solid waste, waste/used oil, etc) through scrap dealer/vendors/traders.
- If the unit desires or proposes any change during the consent period it is mandatory to intimate the PCC for obtaining the consent for establish/operate for any changes etc to be done.
