Premium Moulding., Sr. No. 39/3, Plot no. 1, Silver Industrial Estate, Village-Bhimpore, Daman was issued consent to establish for manufacturing of "Plastic moulded furniture & parts-800 MT/year, other articles of plastic – 50 MT/year, injection & blow moulded plastic articles-150 MT/year (by way of injection/blow moulding only) (no other items)." under Water and Air act valid upto 31/01/2014. The activity falls under **Category-III**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 01/12/2015 along with the following documents;

- ➤ Raw materials used in manufacturing process were granules of Polypropylene, High Density Polystyrene, LDPE, LLDPE, polystyrene, pigment and Master Batch.
- Products being manufactured were Plastic moulded furniture & parts, other injection & blow moulded plastic articles.
- Manufacturing process involved in the unit were injection and blow moulding, cutting and packaging of above mentioned raw materials into final products.
- > Housekeeping observed was in good condition.
