

M/s. Unimax Stationery, Plot. No. D-8 & D-9, Mahatma Gandhi Udyog Nagar, OI DC, Village-Dabhel, Daman was issued consent to establish for manufacturing of "Pens, Ballpens, Nibs, Refills stationery items, Sharpner, Eraser, Calculators, Pen spare parts and accessories – 4 crore pcs/Annum.(no other items)." under Water and Air act valid upto 31/08/2016. The activity falls under **Category-III**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 13/04/2016 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.

- Consent fees under water and air act for Rs 60,000 /-.
- Format of environmental display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

The unit was inspected on 25/04/2016 at 16:00 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was in operation at the time of inspection.
- Raw materials used in manufacturing process were plastic granules of Styrene acrylonitrile and Polycarbonate.
- Products being manufactured at the time of inspection were pens, ball pens, nibs, refills stationery items, pen spare parts and accessories.
- Manufacturing process involved in the unit were injection moulding, printing, refilling, extrusion and packaging.
- Machineries installed in the premises of the unit were 24 injection moulding machines, 2 printing machines, 4 foil machines, 2 sticker making machines, 4 refilling machines, a auto accessories assembling machine and 2 air compressors.
- Unit had not yet started production of sharpener, eraser and calculators so, it had been informed to the representative of the unit that whenever they start the production they had to intimate it to the PCC, Daman for amending the consent to operate for manufacturing sharpener, eraser and calculators.
- Housekeeping observed was in good condition.
- Proper storage facilities were available for raw material and products.
- The unit was availed with septic tank and soak pit for domestic waste water generation.

"In view of the above, Operate to Consent for manufacturing of "Pens, Ballpens, Nibs, Refills stationery items, Pen spare parts and accessories – 4 crore pcs/Annum. (no other items)." which falls in **Category-III** under Water act and Air act along with terms and conditions as mentioned in annexure-I for the period up to 31/03/2018.
