M/s. Shri Krishnashray Pvt. Ltd., Sr. no. 200/1-D & E, Plot no.18, Panchal Industrial Estate, Village-Bhimpore, Daman was issued consent to establish for manufacturing of "Step Lights-50 Nos/Annum, Modilar-2500 Nos/ann, LED Strips-50 MTrs/ann, Lighting Fixtures-50 Nos/annm. (by way of injection moulding and extrusion only). (no other items)." under Water and Air act valid upto 30/06/2013. The activity falls under **Green category**.

The unit has submitted application for grant of consent to Operate under Water and Air act on 07/08/2012 along with the following documents;

- Application form no. XIII under Water Act.
- Application form no. I under Air Act.
- Declaration giving details of capital investment including land, building and plant & machinery without description.
- Consent fees under water and air act for Rs 10000 /-.
- Display sign board.
- Application for authorization to handle Hazardous Waste (form-I).
- Industry Data Sheet.
- Copy of Consent to Establish under Water and Air Act.

Unit had submitted consent fee of Rs.30000 on 22/01/2016 and Rs.8055 on 22/02/2016.

The unit was inspected on 10/02/2016 at 13:30 hrs. At the time of inspection of the unit following observations were noted:

- Display sign board was properly filled with product and waste generation details.
- The unit was in operation at the time of inspection.
- Raw materials used in manufacturing process were granules of Polycarbonate and Nylon.
- Products being manufactured were Step Lights, Modular Switches, LED Strips and Lighting Fixtures.
- Manufacturing process involved in the unit were injection moulding, cutting and packaging of above mentioned raw materials into final products.
- Machineries installed in the premises of the unit were 14 injection moulding machines and 3 compressors having 200 litres capacity each.
- Unit is operating since 2013 without consent to operate.
- Housekeeping observed was in good condition.
- Waste generated during packaging of the products which includes broken corrugated boxes and papers were sold to a authorized recycler whose details are placed in the file.

- Representative of the Unit were instructed to avail all the employees with necessary safety equipment (goggles, safety shoes) & training related to safety precautions to reduce the risk of hazards or accidents.
- Proper storage facilities were available for raw material and products.
- The unit is not significant to pollution potential. As there is no water used during any stage of process.
- The unit was availed with septic tank and soak pit for domestic waste water generation.

In view of the above, Operate to Consent for manufacturing of "Step Lights-50 Nos/Annum, Modilar-2500 Nos/ann, LED Strips-50 Mtrs/ann and Lighting Fixtures-50 Nos/annm (no other items)." Which falls in **Category-III** under water act and air act along with terms and conditions as mentioned in annexure-I for the period up to 30/06/2016.
